Required Actions

Upon completion of the 15-Hour Initial Licensing/Certification Course and Exam

The Tennessee Housing Association does not process your test or mail your test scores. If you have questions relative to your test, please contact the firm of Morris & McDaniel (<u>Kristy@MorrisandMcDaniel.com</u>). Direct Line: 769-287-0548.

If you fail your state exam, you do not need to take the initial training again, but you will need to coordinate the re-taking of your exam. There will be an additional charge of \$125* each time you re-take the exam. You must call or contact Morris & McDaniel directly to reschedule your exam. Neither the Association nor the Department of Commerce & Insurance will do this for you. (*This price may increase in 2024 with the execution of a new contract with the 3rd party testing company.)

Once you receive a passing test score via email or mail, complete the following:
