**License Renewals only:**

1. License Application - please write **RENEWAL** and include your **license number** on the top of this form.
2. Proof of Bond Certificate or continuation form, from insurance provider.
3. [Eligibility Verification Form](#).
4. Class Certificate of Attendance - Directions were provided to you upon completion of the Continuing Education course.

You have 3 options for submitting the noted (4) documents and forms, along with the appropriate License Renewal fee, to the State of Tennessee.

**1. Via Online (preferred):**

Visit the State of TN'S website: <http://core.tn.gov> and create a new account or access your existing account. Follow the provided instructions. There are video tutorials available for your convenience. You will have an option to submit the required forms and application fee.

Please inform them as soon as possible if your address changes, or log into your online account and update the necessary information.
