Contract #59-1-9 for \$43,102.80 to plant a multi species cover crop for 3 years. Contract #59-1-10 for \$28,800.00 to no-till 320 acres for 3 years. Contract #59-1-11 for \$28,800.00 to no-till 320 acres for 3 years. Contract #59-2-12 for \$28,800.00 to no-till 320 acres for 3 year. Spronk made a motion to approve the six contracts.
