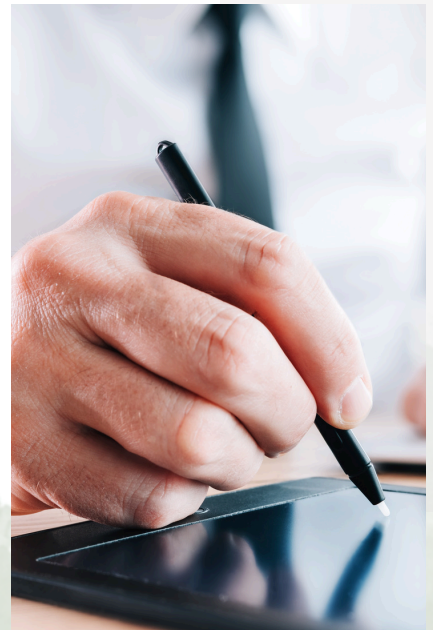
How Does RON Work?
