The polygraph examiner is authorized by this Department to ask any and all questions relating to the information in this booklet or other information they deem necessary. During the polygraph examination, you will have an opportunity to give an explanation on any and all information you disclosed.

In reference to the area of work history, the term "**reprimand**" refers to <u>any</u> verbal or written reprimands or disciplinary actions. In the areas of criminal activity and illegal drugs, the polygraph examiner understands that there may be information you are reluctant to provide or apprehensive to disclose. In addition, the Department needs to assess your involvement in the <u>sale</u> of drugs to another person (with or without profit to you); <u>delivery</u> of drugs to another person; <u>transportation</u> of drugs to be sold; <u>trading</u> of drugs for anything of value; <u>manufacturing</u> of drugs; <u>cultivation</u> of drug plants; or any other manner of involvement in a transaction involving drugs.
