Sexual Abuse Intervention Program

This counselling program is designed for children where sexual abuse is suspected or confirmed and/or for children under 12 with sexual behavior problems.

Youth with Sexual Behaviour Problems Program

This specialized program is intended for non-adjudicated youth ages 12-18 with sexual behaviour problems. Referrals must come through MCFD

Other Forms of Trauma

When funding is available, VCAPCC provides individual and family support for children and youth and their families who have experienced other forms of trauma including physical & emotional abuse

indigenous programming.

The on-going process and dialogue of truth and reconciliation between Indigenous peoples and non-Indigenous helpers and service providers is a primary consideration for the staff of the VCAPCC. We strive to honour the history, knowledge, teachings, and wishes of the communities with whom we work. Therefore, we are providing programming for Indigenous children, youth, and families, provided by counsellors who are also Indigenous persons.

victim services.

Information and support is available to child and youth victims, as well as witnesses and family members throughout their involvement in the criminal justice process.

Victoria Child and Youth Advocacy Centre

Child and Youth Advocacy Centres (CYACs) are child-focused centres that provide a coordinated approach to cases of reported child abuse. A team of professionals, including law enforcement, victim services, and child protection workers, work together to support children, youth, and caregivers who access the centre to ensure that they feel safe, informed, and supported.
