



## Isaacks Ranch Schooling Series

### Hunter and Jumper

March 22, 2025

#### Schedule:

8am: office open / warm up open.

9am: class 1

10am: class 2

11am: class 3

12pm: class 4

1pm: class 5

2pm: class 6

3pm: class 7

All classes will be open for 1 hour. Course adjustments and grooming, if needed, will follow.

**Entries:** Entries must be filled out **completely** by the closing date: 5 days before the show date, Monday. Email entries to [entries@isaacksranch.com](mailto:entries@isaacksranch.com). Late entries accepted. (In an attempt to help keep sanity of the office staff, we encourage competitors to submit entries by the closing date.)

**Payments:** accepted methods of payment; Venmo, Zelle, Paypal, Cash, Check.

#### Fees:

Classes 1, 2, 3, 4, 5, 6, 7: \$20 per class

Late entry classes 1, 2, 3, 4, 5, 6, 7: \$30 per class

Day stall: \$10

Wood Shavings: \$10 per bag; outside shavings allowed wood only.

**Warm up:** Open to all riders on horse, pony, mule, or donkey.

Class is open all day at height of division.

**CLASSES:** We plan to follow USEF rules as close as possible.

Each class will consist of 8-12 jumps jumper type fences (verticals, oxers, triple bars with artificial flowers, brush, decorations, etc....) Classes are open to all riders on any horse, pony, mule, donkey. Ride time per class 2-3minutes, depending on course length.

**Class 1:** Fences .70 m (2'3") spreads to .75 m (2'6")

**Class 2:** Fences .80 m (2'6") spreads to .85 m (2'9")

**Class 3:** Fences .90 m (2'11") spreads to .95 m (3'1")

**Class 4:** Fun class

**Class 5:** Fences 1.00 m (3'3") spreads to 1.15 m (3'9")

**Class 6:** Fences 1.10 m (3'7") spreads to 1.25 m (4'1")

**Class 7:** Fences 1.20 m (3'11") spreads to 1.35 m (4'6")



**Food:** Concessions available on premises.

**Dogs:** All dogs must be on a leash attached to a person. A donation to Isaacks Ranch will be as follows; first offence \$50, second offence \$100, Third offence – removal from property.

**Non-negotiable checks:** If your check is returned for any reason, a penalty of \$35 will be assessed. Exhibitors have 10 days after notification to make full payment plus penalty in certified funds, cashier's check or money order.

**Refunds:** Full refund of all prepaid fees if entry is scratched prior to closing date. After the closing date, the prepaid amount minus the \$10 office fee will be refunded at the end of the show.

**Attire and Equipment:** All riders, including those not competing, MUST wear ASTM certified protective headgear while mounted on a horse or pony anywhere on the showgrounds. NO EXCEPTIONS. All riders participating in the show are required to wear; properly secured ASTM certified protective headgear and hard-soled boots with a heel. Half chaps are permitted. Riders are encouraged to school in proper attire, clinic attire permitted. Safety vests and Air vests are allowed, if wearing an Air vest, a safety vest is required underneath it.

**Fun Class:** Open to all riders. Riders must wear helmets and closed-toe shoes. To be shown at walk, trot, canter both directions and subject to testing at the discretion of the judge.

**Stalls:** 80 permanent 10x10 box stalls. Three sides wood with metal pipe front with door.

**Parking:** All horse trailers will park in the Stabling area, no exceptions. Regular vehicles may park by arenas in designated areas. No parking next to arena fences.

**Toilets:** Portable Toilets on grounds, hand sanitizer.

**Notice:** There is a working cattle ranch next to Isaacks Ranch, cattle may be present. Desert wildlife may be present, coyotes, snakes, etc.

**Code of Conduct:** Please be courteous towards your fellow horse-people, this is an educational opportunity. Decorum is essential, any person(s) acting in an uncivilized manner may be dismissed from the property.
