All classes will be open for 1 hour or 30 minutes depending on the number of riders. Course adjustments and grooming, if needed, will follow.

Dressage Schedule:

Open schedule

Ride a test in front of a peer.

XC course: open for schooling, water jump filled. **\$35**

Western Trail course: includes xc water jump and steps/hills **\$35**

Entries: Entries must be filled out **completely** by the closing date: 3 days before the show date, Wednesday.

Payments: accepted methods of payment; Venmo, Zelle, Cashapp, Cash.

Fees:

Classes 1, 2, 3, 4, 5, 6, 7: \$20 per class

Dressage Test of choice: \$20 per class
Late entry classes 1, 2, 3, 4, 5, 6, 7: \$30 per class (day of sign up)

Day stall: \$10

Wood Shavings: \$10 per bag; outside shavings allowed wood only.

Warm up: Open to all riders on horse, pony, mule, or donkey. Class is open all day at height of division.

CLASSES: We plan to follow USEF rules as close as possible. Each class will consist of 8-12 jumps jumper type fences (verticals, oxers, triple bars with artificial flowers, brush, decorations, etc....) Classes are open to all riders on any horse, pony, mule, donkey. Ride time per class 2-3 minutes, depending on course length.

Class 1: Fences 1.00m(3'3") spreads to 1.15m(3'9")

Class 2: Fences .90m(2'11") spreads to .95m(3'1")

Class 3: Fences .80m(2'6") spreads to .85m(2'9")

Class 4: Fences .70m(2'3") spreads to .75m(2'6")

Class 5: Fences .60m(1'11") on oxer

Class 6: X rails(12" max)

Class 7: Lead line

Dogs: All dogs must be on a leash attached to a person. A donation to Isaacks Ranch will be as follows; first offence \$50, second offence \$100, Third offence – removal from property.

Non-negotiable checks: If your check is returned for any reason, a penalty of

\$35 will be assessed. Exhibitors have 10 days after notification to make full payment plus penalty in certified funds, cashier's check or money order.

Refunds: Full refund of all prepaid fees if entry is scratched prior to closing date. After the closing date, the prepaid amount minus the \$10 office fee will be refunded at the end of the show.

Attire and Equipment: All riders, including those not competing, **MUST** wear ASTM certified protective headgear while mounted on a horse or pony anywhere on the showgrounds.

NO EXCEPTIONS. All riders participating in the show are required to wear; properly secured ASTM certified protective headgear and hard-soled boots with a heel. Half chaps are permitted. Riders are encouraged to school in proper attire, clinic attire permitted. Safety vests and Air vests are allowed, if wearing an Air vest, a safety vest is required underneath it.

Stalls: 80 permanent 10x10 box stalls. Three sides wood with metal pipe front with door.

Parking: All horse trailers will park in the Stabling area, no exceptions. Regular vehicles may park by arenas in designated areas. No parking next to arena fences.

Toilets: Portable Toilets on grounds, hand sanitizer.

Notice: There is a working cattle ranch next to Isaacks Ranch, cattle may be present. Desert wildlife may be present, coyotes, snakes, etc.

Code of Conduct: Please be courteous towards your fellow horse-people, this is an educational opportunity. Decorum is essential, any person(s) acting in an uncivilized manner may be dismissed from the property.
