President Folland gave a brief description of what was involved in writing Ordinance 2016-17. Jill Powers then read the Ordinance and the Chapters involved so that the public could have a better understanding of what was written.

2. ORDINANCE 2016-18: AN ORDINANCE TO ESTABLISH PARKING REGULATIONS UPON THE ROADS AND STREETS WITHIN THE TOWN OF CLEAR LAKE, INDIANA
