MINUTES OF JANUARY 12TH, 2015 TOWN COUNCIL MEETING

The regular meeting of the Town Council of Clear Lake, Indiana was held at the Town Hall on Monday, January 12th, 2015 at 7:00 p.m. Present were Council members Robert Lewis, Roger Dammeier, Alan Korte, Chris Folland and Jill Powers. Also present were Town Superintendent, Robert Hull and Deputy Rich McCarty. There were three citizens who signed the guest register.

Council President, Robert Lewis called the meeting to order at 7:00 p.m. with the Pledge of Allegiance.

Prior to the start of the meeting, Robert Lewis introduced Roger Dammeier as the new Council Member who was appointed to complete the four-year term vacated by Barry Worl.

COUNCIL ACTIONS:

- 1. The first order of business for 2015 was the nomination and election of officers. A motion was made by Jill Powers to nominate Chris Folland as Vice-President. The motion was seconded by Roger Dammeier, all were in favor.
- 2. Robert Lewis was nominated by Jill Powers to the President's position. The motion was seconded by Alan Korte, all were in favor.
- 3. Approval of minutes December 8th regular meeting: Alan Korte moved to approve the minutes from the December 8th, 2014 regular meeting, seconded by Jill Powers, all were in favor.
- 4. Approval of Financial Report for December 12th: No Report for December. Approved at the January meeting.
- 5. Approval of Voucher Register: Roger Dammeier moved to approve the Voucher Register as submitted, seconded by Alan Korte, all were in favor.

UNFINISHED BUSINESS:

1. There was a meeting with Larry Gilbert, Steuben County Surveyor, the County Attorney, Bob Lewis, Bob Hull, Chris Folland and our attorney, Dave Hawk on December 13th to discus who is responsible for the Cyrus-Brouse ditch that goes under the road between #930 & #932 South Clear Lake Drive. It was determined that the County is responsible for the ditch all the way to the lake. Larry Gilbert will make a recommendation to the Drainage Board at their meeting on December 22^{nd.} The Drainage Board will then make a recommendation to the Commissioners. The Commissioners will take it under advisement and schedule a public hearing on the project. Larry Gilbert has agreed to keep DLZ Engineers on the project to do the engineering for the County. The Town will be responsible for the improvement cost for the portion under the road.

NEW BUSINESS:

- Council Appointments: A motion was made by Alan Korte to appoint Roger Dammeier to complete Robert Lewis's term on the Plan Commission which ends December 31, 2015. The motion was also made to appoint Chris Folland to the Plan Commission for another four-year term which co-insides with his term on the Town Council. The motion was seconded by Jill Powers, all were in favor.
- 2015 Road Projects: To be determined after Buck Point and Twin Culverts. First after those two would be West Clear Lake Drive from north of the Yacht Club to Penner Drive.
- 3. Proposed Leaf pick-up dates for 2015: Proposed dates for the Spring are the first week in May, the week before and week after Memorial week-end. In the Fall the time period will be from the first week in October thru the first week in December. These dates are subject to weather conditions and will be published in the Association newsletters.
- 4. American Legal: Code of Ordinance codification. The ordinances have been sent to American Legal and the estimated cost if between \$600 and \$1200 with the preliminary estimate being \$912. Council members gave approval to have the ordinances codified.
- 5. DLZ Engineers: 2015 Professional Service Agreement for Engineering Services. Council signed agreement with DLZ to continue to provide services to the Town.

There being no further business a motion was made by Chris Folland to adjourn the regular Town Council meeting. The motion was seconded by Alan Korte, all in favor.
