MINUTES OF MARCH 8^{TH} , 2013 TOWN COUNCIL MEETING

The regular meeting of the Town Council of Clear Lake, Indiana was held at the Town Hall on Friday, March 8th, 2013. Present were Council Members Robert Lewis, Chris Folland & Alan Korte. Also present were Town Superintendent, Bob Hull and Phil Hibbert from DLZ Indiana. There were three citizens who signed the guest register.

Council President, Robert Lewis called the meeting to order at 10:00 a.m. by asking those in attendance to stand and recite the Pledge of Allegiance.

President, Robert Lewis asked if there were any additions or corrections to the minutes of the February 11th, 2013 Council meeting. There being no additions or corrections Bob asked for a motion to approve the minutes as presented. The motion was made by Alan Korte to accept the minutes as presented, a second was made by Chris Folland. All council members present were in favor and the motion passed.

The Clerk/Treasurer gave the Treasurer's Report as of February 28th, 2013. Robert Lewis asked for a motion to approve the Treasurer's Report as presented. SEWER DEPARTMENT

There were 3 sewer locates, 7alarm calls, 5 pumps replaced, and an average daily flow of 17,138 gallons per day.

There were no problems with the system.

STREET DEPARTMENT

Much of Bob's time in February for the Street Department was spent plowing snow along with building and equipment maintenance and repairs.

The furnace on the south side of the barn that was moved from the Old Town Hall and installed when the barn was built needs to be replaced. Bob has received a quote for \$1,340 from the Housewrights to install the used furnace that Kathy Latz donated to the Town several years ago. This would include fabricating a metal box that it would sit on to meet code, duct work for

proper circulation and disposing of the old furnace. The Council approved the appropriation of \$1,340 per quote.

BILLING DEPARTMENT - Bob Hull

<u>SOLID WASTE</u> – The invoices for trash collection will be mailed out by the first week in April this year and will be due by May 1st. If payments are not received by May 15th outstanding accounts will be accessed a 10% last fee. For those customers signed up for auto-draw your designated accounts will be drafted on May 15th.
