

TOWN OF CLEAR LAKE, INDIANA SPECIAL SESSION TOWN COUNCIL MEETING JUNE 4th, 2020

The Special Session Council meeting of the Town Council of Clear Lake, Indiana was held at the Town Hall and by teleconference on Thursday, June 4th, 2020 at 7:00PM. NEW BUSINESS:
