MINUTES OF August 1st, 2016 TOWN COUNCIL SPECIAL MEETING

The Special meeting of the Town Council of Clear Lake, Indiana was held at the Town Hall on Monday, August 1st, 2016 at 6:00 p.m. Present were Council President Chris Folland and members Roger Dammeier, Bruce Spangler, Jill Powers and Anita Thiel.

COUNCIL ACTIONS:

- 1. New hire for Deputy Marshal: Council member Jill Powers recommended hiring Adam Kitson for the position of Deputy Marshal. Adam is a graduate of Prairie Heights Schools, attended Tri-State University, graduated from the Police Academy and is currently employed in the Town of Fremont. Adam will become official after receiving the Deputy letter from Fremont giving their approval. The motion was made by Bruce Spangler to approve the hiring of Adam Kitson as a Deputy Marshal to serve the Clear Lake community. Roger seconded the motion. All were in favor.
- 2. 2017 Ford F550 Dump Truck: Quotes submitted are on file.

Roger Dammeier made the motion to purchase the cab & chassis from Jim Schmidt Ford in Hicksville, OH for the quote of \$43,195 and the dump bed with salt spreader from Kalida Truck Equipment in Kalida, OH for the quote of \$20,400. Total cost of \$63,595. Motion seconded by Bruce Spangler. All were in favor.

Bruce Spangler made the motion to award Part 1, 2 & 11 to Brooks Construction for a total bid of \$195,828.50 and delay awarding Part 1B the drainage improvement on South Clear Lake Drive until another quote is obtained. The motion was seconded by Roger Dammeier. All were in favor.

- 4. Letters of financial commitment: Letters dated July 29, 2016 to qualify for the Community Crossings 50/50 Matching Grant Program.
 - a. Letter committing \$61,916.79 from Major Moves Fund and \$6,925.52 from LOIT Special Distribution Fund totaling \$68,842.31 for Part 1, 1B & 2 of the South Clear Lake Drive 2016 Street Improvement Project.

Roger Dammeier made the motion to approve the Letter of Financial Commitment totaling \$68,842.31 for the 50/50 Matching Grant Program. The motion was seconded by Bruce Spangler. All were in favor.

b. Letter committing \$58,551.06 from LOIT Special Distribution Fund for Part 11 of the East Clear Lake Drive 2016 Street Improvement Project.

Roger Dammeier made the motion to approve the Letter of Financial Commitment totaling \$58,551.06 for the 50/50 Community Crossings Matching Grant Program. Jill Powers seconded the motion, all were in favor.
