
# Fall 2024 Newsletter

# Marshal's Report

We have had a safe summer thus far, and as the Town Marshal, I would like to thank each resident for doing their part to make this happen.

As the leaves start to turn and fall, please do not pile them up in the roadway. The roadways around the lake are narrow, and the piles create a hazard to motorists. Please place the piles at the edge of the roadway, but still in the grass area next to the road.

As Fall sets in on the lake community and things begin to slow down, I want to take a moment and remind everyone to use common sense when preparing your seasonal residence for the winter. Please refrain from making changes to your seasonal residence that make it apparent nobody is home in the off season.

For tips on how to protect your home while away on vacation or for seasonal homes, visit the National Crime Prevention Council site at ncpc.org or simply google "tips for protecting homes while on vacation." Most of the sites I have visited have some good tips that work for seasonal residences, such as lake homes.

I would like to remind everyone who is coming to and from the lake to look for and report any suspicious activity right away. This basic level of a neighborhood watch program has proved to be very successful. At the Clear Lake Police Department, we encourage all of our residents to remember an easy phrase: "See something, say something".

If you see suspicious activity or something that just doesn't look right, we encourage you to contact us immediately at our dispatch number of (260) 665-3131 or 911 in the event of an emergency.

We need the help of all our residents to keep a safe and secure community.

I am pleased to welcome our newest Officer, Austin Batt, to the Police Department. Austin is a full-time Deputy at the Steuben County Sheriff's Office and was a police officer in Montpelier, Ohio for a few years. Please welcome Austin if you see him.

The officers will be working varying shifts throughout the fall and winter months to help deter crime. If you see one of us out, please feel free to stop us, if nothing else just to say "hello."

# Town of Clear Lake Updates

Trash rates will be increasing January 1, 2025. The new rate for a single bin is \$25.89 (yes, \$1.10 increase) and \$51.78 for two bins.

### Lakeview Drive Improvement Project - starting September 9th!

**Phase I**: September 9-14th: from 7740 E 750 North to 132 Lakeview

**Phase II**: September 16-18: 132 Lakeview to 262 Lakeview **Phase III**: September 20-26: 264 Lakeview to 8475 East 700 North

Paving is tentatively scheduled for September 27, 30 and October 1.

This schedule could be impacted by weather and other factors but the grant funding is dependent on completing the project on time.

Please do not remove or move barricades or flags marking utilities.

Trash pick up: If you reside in the listed area, your trash and recycle will be picked up first and early. You will need to have your trash bins out the night before (Sunday). Pick up day will remain the same day (Monday) and not change. All other residents might notice their pick up time is a bit later during this timeframe.





### Grinder Glitches

The Town of Clear Lake would like to remind you of the following:

Please don't wait until the last minute if you think something is not working as usual. Our Sewer Superintendent often hears "we noticed something was different a few days ago...".

Remember that it is easier to work on the grinders and pumps when it is daylight and it is also less bothersome for you and your neighbors.

Please also note that according to our Town Ordinance, grinders need to have a 5' clearance of any plantings and objects in all directions. There must be a clear line of sight from the road.

### Keep in mind, this is for the safety of your home!

If you look closely at the photos on this page, you'll see that NOT all of them are in compliance. The Town will be looking at those that are out of compliance this Fall.

As fall approaches, we are fortunate to have experienced yet another wonderful summer with our Clear Lake community.

Let's look at some of our highlights so far this year and learn more about what's to come.



We enjoyed our 20th year of Knee-high Naturalists!



This annual educational program has carried on through the years thanks to the vision of Josie Kramer and Megan Morris, along with the support of Dana Buehrer, Tracy Hughes and many other volunteers and donors inspiring the environmental education of our youth.



This summer, we reached more than 140 individuals through sessions including the Dumpster Drummers, a butterfly hike, a water resources lesson, and a visit from Smokey Bear and Woodsy Owl.



Run Day, Fun Day on July 13 was a huge success with 64 volunteers, 109 runners, 42 walkers, and plenty of friends and family cheering alongside the race.

After the race, many enjoyed the Fun Day bounce house, dunk tank, scavenger hunt, face painting, and music.

We are extremely grateful for all sponsors and donors that came together to raise just over \$38,500 in support of our work and mission.

This community is the heart and soul of our organization, and we are honored to be able to host this annual event to celebrate and appreciate our special Clear Lake.

#### What's next?

With just 4 months left in 2024, the Conservancy still has plenty of projects and programs to look forward to:

- Join us this Saturday, August 31 st at 10 AM at Memorial Woods to learn about raptors in Indiana and see live educational birds with Soarin' Hawk Raptor Rehabilitation.
- Take a hike on the **new prairie trail** through the Clear Lake Nature Preserve as the native flowers are blooming through the fall.
- Learn how to identify **macroinvertebrates** as part of our water quality testing on Wednesday, September 18 at 9 AM at the Lutheran Church Pavilion.
- Participate in the Indiana Audubon's **Big Day Hike** at Brennan Woods on October 12th at 10 AM.
- Stay tuned for a data summary from the Watershed Diagnostic Study as we continue this extensive water quality monitoring project.



As always, we are thankful for our dedicated volunteers that assist with our projects through the year.

Our 2024 projects have included Neighborhood Cleanup, Garlic Mustard Pulls, monthly Water Quality testing, Kasota Island Cleanup, Tribute Garden Landscaping, and trail maintenance projects.

## CLTLC's Fall Tips for a Healthy Lake

Fall describes exactly what we expect to happen with all of our leaves. As tempting and convenient as it might seem, we ask you to keep leaves, grass and other yard waste out of the lakes, wetlands and inlets, and out of Conservancy Preserves. If you hire individuals or a company to assist with your leaf clean up, help them understand that putting leaves in the lake is damaging.

### Consider these other fall tips:

- If you (or your lawn service) apply a fall lawn fertilizer application, do so sparingly and only use non-phosphorus fertilizer (the middle number on the bag should be zero).
- Leave a strip of unfertilized lawn along the lake edge to create a buffer.
- Use the Town of Clear Lake's Leaf Pick-Up Program.
- Pick-up pet waste.

### Ways to Dispose of "Non-Mulchable" Yard Waste

Northeast Indiana Solid Waste Management District (NISWMD) accepts "non-mulchable" yard materials such as grass clipping, leaves, and brush. No stumps or land clearing materials.

The closest site is located at CR 175 N- NW of Angola adjacent to the Steuben County Fairgrounds. Check their website at niswmd.org or call 260-587-3063 for more information.

### Used Boat Motor Oil and Household Hazardous Waste Disposal

Clear Lake Marina will dispose of used boat motor oil. Call 260-495-4915 for details.

Northeast Indiana Solid Waste Management District (NISWMD) has a program to properly dispose of residential hazardous waste materials including paint, light bulbs, batteries, and other items. Details at niswmd.org/hazardouswaste/

#### Stop the Spread of Invasive Aquatic Plant Species

- Drain ballast water before leaving the access site.
- Thoroughly rinse all watercraft and trailers BEFORE entering and AFTER exiting any lake, river or stream.
- Dry all areas of the boat before relaunching into a new body of water.
