

Junkyard Gem: 1992 Mazda MX-5 Miata

Not every early Miata gets to become a race car.

The Mazda MX-5 Miata has been with us for nearly 35 years now, giving the world what it had lacked for so long: a two-seat convertible that was just as affordable and fun as the MGB or Fiat 124 Sport Spider had been... but without the horrid reliability and leaky tops of those cars. Intact Miatas haven't been easy to find in the car graveyards I frequent, because worn-out ones tend to end up in the hands of racers before they can reach your local Ewe Pullet. I run across plenty of picked-clean and/or crashed-beyond-recognition Miatas during my junkyard travels, but today's '92 in a Denver self-service yard is unusually complete and un-smashed.

The odometer shows nearly 225k miles. I think this car spent a couple of decades as a reliable daily commuter, then got parked in a driveway or yard when something broke.

The MSRP for a 1992 MX-5 was \$14,200, or about \$31,373 in 2023 dollars. 20 years earlier, the inflation-adjusted price for a new MGB roadster had been just \$24,646. However, the price of a new 2023 Miata starts at \$28,050, so it's both faster and cheaper than it was 21 years ago.

Some Ford F-150 trucks are making 'sonic boom' and 'ear-piercing static' noise

Instead of enjoying the mellifluous tones of Lady Gaga or the bounce music of the Arctic Monkeys, some drivers of newer Ford F-150 pickups are hearing unexplained loud crashing sounds, the noise of shattering glass, or high-pitched static through the cockpit's speakers. This phenomenon has prompted more than a hundred complaints to Ford, some by customers who say the noise was so distracting that they either had to pull over and stop driving, or if parked, didn't feel it was safe to get on the road.

The automaker issued a technical service bulletin recently addressing the noise issue in Expedition SUVs and the F-150 pickups from the 2021-23 model years, and the 2022 F-150 Lightning electric trucks. Ford says its related to the amplifier in the vehicles' sound systems, which seems obvious.

Without detailing the actual cause, the company says that it has developed a software fix that customers can get at dealerships or through a downloadable update. The fix supposedly adjusts the amplifier to filter out the speaker noise.

"We are working swiftly to make sure this is resolved for our customers," a spokesperson said.

In online forums, F-150 owners have been hearing a "sonic boom" or "ear-piercing static." Drivers, in some cases, were able to turn it off right away. Others say it lasted for 15 minutes or more, persisting even after the car was shut off. Several drivers who have complained to the National Highway Traffic Safety Administration said the noise was above 100 decibels, a level similar to that of a loud concert or a car horn, according to the American Academy of Audiology.

A spokesperson from the National Highway Traffic Safety Administration said that the agency is aware of the issue.
