



You can HELP Save Deer Run!

On May 19, 2020, Commissioner Bob Dallari introduced the idea that Seminole County purchase the former Country Club at Deer Run golf course to turn it into a passive recreation park at a county work session with the other Seminole County commissioners. If the county purchased the closed golf course, it would help prevent development so no houses were built, it would add walking & biking trails, protect the green space wild life calls home, keep Sterling Park Elementary from becoming further overcrowded, and add new amenities to the community like a large playground, putting green, splash pad, fishing dock, or other passive recreation activities selected by Deer Run residents. The county will only purchase the closed golf course if a minimum of **THREE of five county commissioners vote to buy it.** If you are worried about the future of the golf course, we encourage you to reach out to the Seminole County Commissioners via telephone, postal mail, and/or email. Below is a sample email which can be used in this email campaign. Please feel free to tweak it so it reflects YOUR personal reasons as to why you think the county should buy the former course. At the May 2020 work session, Commissioners Constantine, Dallari, & Zembower seemed to view the idea positively. Commissioner Carey spoke out against it. Commissioner Lockhart remained silent.
