Treasurer's Report:

Activity this month was for Groomer Fuel, Groomer Repairs, Groomer Payment, Permits and Trail Supplies. Ending balance is \$63,249.90. A motion was made by Keith, seconded Kerry Barnard and passed to accept the December 2025 Treasurers report as written.

The first benchmark was sent in for \$34,456.50. It looks like everyone's trail set-up reports were turned in. Please make sure to fill out groomer reports.

New Business:

- Right of Way Permits: We are finding out that we do not have current land owner permits with city's and townships. Tom has some examples that will be included in the minutes email. Most have been handled via email smoothly. If you get a verbal authorization, you will still need to fill out a land owners permit and write that it was a verbal authorization. Follow all verbal ok's with an email for

documentation. State law does give snowmobiles the right to use ditches, but once it is signed for trail, it will need a permit for groomers to have permission for use. When talking to the cities don't make a big deal for needing the permits, just come across that we are needing to update. Chris went through the cities needing updating, all are being worked on or will be worked on soon. Send all permits to Tom and Ted.

- Groomer/Equipment Issues: After the first snowfall repairs were needed for St. Michael and Monticello Groomers, all others are in good shape.
- Argo: Conversation is to have Dwayne look into what is needed to repair, then we will need to decide if it is worth repairing or if it should be replaced.
- Albertville Club will be dissolving as a lot of the older members are no longer active. St. Michael will take on what they can for trail and members, they may ask for helps in areas that make sense for other clubs.
- Bridge at Paumen Property: The mats are rotting and were suppose to be removed. The plan is to look for a trailer to be able to put in and pull out seasonally. Char and Robin may have a trailer that will work, Marty will go look at it. Dave also might have a trailer that will work. Curt made a motion to allow the club to spend up to \$1,500.00 to find something to solve the issue to avoid using the road for the trail. Brandon seconds and the motion passes.

- Great job to all that set up trails, the short time that people were able to get out and ride the trails were good.
