If pictures are provided of the updates before the report is complete the rating could go into effect this year. In addition, Eric Kwasniewski included that the security cameras/software are no longer supported and will need to be updated, they received a quote of 3,000.00 from Glacial Lakes Technology, both grass firetrucks are in need of tires, each set is estimated to be around 1400.00, the hot water circulator pump has went out at the station estimated repair cost is 1400.00. Motion by Mount, seconded by Klungseth, to proceed with the purchases and repairs requested. Motion carried.
