Richard Misterek, Lundee Stadtler, Terry Hoffman, Eric Martinson and Kathy Holman representing Community Transit, came before the council presenting that they would like to install a bathroom and an office space in the transit bus barn. The City owns the building so that is why they are asking for permission. They have applied for a grant and have been approved for funding. Questions came up about the water sewer hookup for the bathroom about the size of the pipe and where it can be hooked up from. The city will need to do some checking and will get back to them on this.

Chad Goehring, Water Superintendent and Jeff Fossum from South Dakota Association of Rural Water Systems came in to talk about the industrial park sewer. Fossum said our hospital lift is showing alot running through it. Fossum also noted that we have a good scada system that shows the flow that is pumping in that area. They did do a smoke test, which they blew smoke into manholes checking if there were any leaks. Also they did camera that area and found where some pipe was not put into the gaskets, lots of infiltration, calcium build up around the pipe due to leaking for so long and chemical in the sewer line.
