7:00 p.m. This being the time and place for a hearing for Eric Kracke, 110 East 3rd Avenue, described as Lot 20 ex W66' of E134' McKennett's and Lot 21, Day County, South Dakota, a request to rezone from residential to commercial for the purpose of building a 60'x65' storage building for business and recreational equipment. Roland Larson mentioned he would like the property surveyed so they know where the lot lines are. Council informed Larson that Kracke's property would be surveyed but that he (Larson) would need to survey his own property if he wanted to know where his pins are. Motion by Miller, seconded by Sinner to deny the rezoning proposal as presented with the legal description given for the property. Motion carried.

7:05 p.m. Volunteer Fire Department members Eric Kwasniewski, Wes Hoven and Jeff Smidt presented the 2023 annual report. The Fire Department responded to 32 calls in 2023. There are currently 20 active members. Major improvements this year: updated SCBA air packs and fill station. The following items were discussed for this year: training room equipment such as a smart TV and a projector, possibly some new hoses and nozzles, new laptop. The county is still working on fixing the radio system that will require new programming eventually. Also, it was mentioned the fire department is still low on numbers for volunteers. Motion by Miller, seconded by Klungseth to approve the 2023 annual report and to pay for call hours. Motion carried.

Anderson also talked about the mitigation plan, which is a plan to be eligible for FEMA grants. It includes preparations for natural hazards like flood, fire, storm. Crisis Track is the new online software and app that is used for collecting data for FEMA. We will need to meet with NECOG in the future to discuss a plan. Motion by Klungseth, seconded by Miller to adjourn. Motion carried. Next regular scheduled meeting is March 4, 2024 at 6:30 p.m.
