ASSIGNMENT

1) I was retained by Bell Canyon Association ("BCA") to perform a forensic accounting review of legal expenses related to Hudock Employment Law Group ("Hudock") and Pariser & Pariser LLP ("Pariser") resulting from BCA former president Eric Wolf's potential misuse of funds.

LIMITATIONS

2) This report was prepared for BCA Board of Directors information use only.

FORENSIC ACCOUNTING FINDINGS

\$115,000 Eric Wolf's Personal Lawsuit Settlement Amount Was Paid Using BCA Funds

- 3) On June 28, 2021, two checks issued by Fidelity National Title, related to an anti-SLAPP motion were deposited into the Wolf, Rifkin, Shapiro, Schulman & Rabkin, LLP WRSSP) BCA Trust Account. These funds were associated with legal proceedings initiated by Leon and Marina Reingold and were intended to reimburse legal fees incurred in the process.
- 4) The two checks were as follows:
 - > \$25,127.08, made payable to Bell Canyon Association (BCA)
 - > \$71,359.78, made payable to Eric Wolf
- 5) These deposits totaled \$96,486.86 and both were received under the same anti-SLAPP reimbursement context. In an email dated June 23, 2021, Eric Wolf expressly acknowledged that the check for \$71,359.78 was issued to reimburse legal expenses incurred during the anti-SLAPP proceedings. However, documentation and BCA records indicate that the legal expenses in question were actually paid by BCA, not Mr. Wolf

personally.

- Therefore, the check made payable to Mr. Wolf should rightfully have been endorsed back to BCA. Retaining the reimbursement, in effect, diverted association funds intended to offset prior legal expenditures borne by BCA. As previously noted, while the check was deposited into the WRSSP BCA Trust Account, the funds were ultimately used to pay for Mr. Wolf's personal lawsuit settlement.
- 7) On December 13, 2022, a disbursement of \$97,230.61 was made from the BCA WRSSP Trust Account toward the settlement of Eric Wolf's personal legal matters. These legal matters included:
 - Reingold v. Wolf (Cross-Complaint)
 - Vorobiev v. Wolf
- 8) In addition, on the same date, an extra check in the amount of \$17,769.39 was issued by BCA directly to Leon and Marina Reingold, bringing the total outlay related to Mr. Wolf's personal legal settlements to \$115,000. See Appendix B, Schedule 1.
- 9) On December 5, 2022, during a remote emergency meeting, the Litigation Committee approved a \$115,000 settlement related to a cross-complaint involving the Reingolds. However, when Eric Wolf reported on the settlement, he did not specify which cross-complaint the settlement pertained to. There were two cross-complaints at issue: one related to Eric Wolf's personal lawsuit with the Reingolds, and the other filed by BCA. By failing to clearly indicate which cross-complaint was being settled, it appears Eric Wolf may have been seeking approval for the settlement of his personal lawsuit. As noted in the January 17, 2024 Executive Board of Directors Meeting minutes, the Committee believed they were approving the settlement related to the Reingold v. BCA cross-complaint. See Exhibits 4 and 5.
- 10) This sequence of events raises significant governance and fiduciary concerns, as it

represents:

- A misclassification and misappropriation of funds originally intended to reimburse BCA:
- An unauthorized use of Association funds to settle private legal matters; and
- A lack of board oversight and transparency in handling substantial financial transactions involving personal benefits.

<u>Unauthorized Payments to Hudock Due to Missing Board Approval and Payments</u> <u>Made Prior to Signed Retainer Agreement</u>

Background and Retainer Details

- 11) I was informed that the only written retainer agreement between BCA and Hudock was signed on February 8, 2023. According to the terms of this agreement, Hudock was retained to represent BCA specifically in the matter of Reingold v. Bell Canyon Association.
- However, a review of the BCA check register (See Exhibit 6), obtained from the Association's accounting firm, Seabreeze, reveals that payments to Hudock began long before the formalization of the retainer. Between August 18, 2017 and July 31, 2023, BCA paid a total of \$2,015,108.61 to Hudock, of which \$1,636,881.74 was paid prior to the signed retainer date of February 8, 2023. See Appendix B, Schedules 2 and 2.1.
- 13) This raises concerns regarding the legality and authorization of the payments made during that period, as no formal agreement was in place to define the scope of work, hourly rates, responsibilities, or payment terms.

Violation of Assembly Bill 2912 (AB 2912)

14) Effective January 1, 2019, Assembly Bill 2912 was enacted to strengthen financial protection for homeowners associations (HOAs) in California. Among other provisions, AB

2912 prohibits the automatic or electronic transfer of amounts exceeding \$10,000 or 5% of the HOA's total combined reserve and operating accounts (whichever is less), without prior written approval from the Board of Directors.

15) Under this law, any individual check exceeding \$10,000 paid to a vendor, including legal counsel, must have written board authorization.

Lack of Board Approval

- A comprehensive review of BCA's Board Meeting and Litigation Committee Meeting Minutes from 2017 through 2023 revealed that the majority of checks written to Hudock in amounts exceeding \$10,000 were not approved in writing by the Board, either through formal resolutions or meeting minutes. It appears that, starting only on February 8, 2023, invoices over \$10,000 were presented for approval by the Litigation Committee. However, it seems White Zuckerman has not received complete copies of the Litigation Committee meeting minutes after February 8, 2023 through July 31, 2023; therefore, I considered any payments that were not specifically approved in the pages I received, as unauthorized payments. See Exhibit 3.
- 17) It should be noted that during a Litigation Committee Meeting held on February 8, 2023, a motion was unanimously approved to ratify all legal bills over \$10,000 from 2022. See Exhibit 2. The ratification referred to a .zip file presented to the committee. Since I have not received this file, I am unable to verify whether the payments to Hudock were included. Additionally, I cannot determine whether such a delayed and general ratification is legally valid.
- 18) Accordingly, payments made under the following conditions are considered unauthorized:
 - > Payments made prior to the formal retainer date (August 18, 2017 to February 8,

2023), totaling \$1,636,881.74

- Payments made after the retainer date, for checks exceeding \$10,000 through July 31,
 2023, that were not approved by the Board or Litigation Committee.
- 19) As a result, payments made to Hudock during this period—totaling \$1,873,860—are deemed unauthorized, either due to the absence of a binding legal agreement or failure to comply with statutory financial controls and board governance requirements. See Appendix B, Schedule 2.

Conclusion and Implications

20) Given the absence of a valid retainer agreement for nearly six years of legal services and the consistent failure to obtain proper board approvals for large payments as required by California law, the majority of the payments made to Hudock between August 18, 2017, and July 31, 2023, may be categorized as unauthorized disbursements.

<u>Unauthorized Payments to Pariser Due to Missing Board Approval</u>

Background and Payment Overview

- 21) It has been reported that the law firm Pariser was retained by BCA to represent the Association in multiple legal matters over a multi-year period. While the engagement of legal counsel is standard practice, such engagements—and the payments resulting from them—must adhere to statutory requirements and internal governance protocols.
- According to records covering the period February 2017 through July 31, 2023, BCA issued a total of \$1,378,364 in payments to Pariser for legal services. Notably, \$1,305,753 of this amount was made through individual checks exceeding the \$10,000 threshold.

Violation of Assembly Bill 2912 (AB 2912)

23) As stated above, under Assembly Bill 2912, which became effective on January 1,

2019, no electronic or check payment over \$10,000 (or 5% of an HOA's combined reserve and operating account balances, whichever is lower) can be made without prior written approval from the board of directors. This statute was enacted to prevent unauthorized financial transactions and safeguard HOA funds.

Lack of Board Authorization

- A thorough review of BCA's Board Meeting and Litigation Committee Meeting Minutes from 2017 through 2023 revealed that payments over \$10,000 were approved starting only on February 8, 2023. However, it appears that White Zuckerman has not received complete copies of the Litigation Committee meeting minutes for the period following February 8, 2023, through July 31, 2023. Therefore, any payments not specifically documented as approved in the pages I received have been considered unauthorized. See Exhibit 3.
- 25) It should be noted that during a Litigation Committee Meeting held on February 8, 2023, a motion was unanimously approved to ratify all legal bills over \$10,000 from 2022. See Exhibit 2. The ratification referred to a .zip file presented to the committee. Since I have not received this file, I am unable to verify whether the payments to Hudock were included. Additionally, I cannot determine whether such a delayed and general ratification is legally valid.
- 26) As a result, all checks issued to Pariser after January 1, 2019, that exceeded the statutory threshold and lacked valid authorization from the Board or Litigation Committee—

 totaling \$1,015,455—are considered unauthorized disbursements under California law.

 See Appendix B, Schedules 3 and 3.1.

Other Potential Billing Issues

27) On October 12, 2018, the Bell Canyon Association (BCA) issued a check in the

amount of \$208,621 to the Hudock Employment Law Group for Invoice #240, dated the same day. The invoice covered legal services purportedly rendered over an 11-month period—from September 2017 through July 2018—in connection with the case David Chai v. Bell Canyon Association, Inc. The check was signed by Diana Roster and Eric Wolf. During the period August 18, 2017 through July 20, 2023, Eric Wolf signed at least 16 of the 50 checks written

Based on information provided, Pariser was the law firm officially representing BCA in the David Chai matter during this time. Simultaneously, it is understood that Hudock Law Group was representing Eric Wolf personally, not BCA. This raises a critical concern that legal expenses related to Mr. Wolf's personal defense were inappropriately charged to BCA.

to Hudock Employment Law Group. See Appendix B, Schedule 2.1 and Schedule 2.1A.

29) Further adding to the irregularity, the invoice was issued nearly a year after the legal services allegedly began, and it encompassed an unusually long billing period without any apparent interim invoicing. This delay, combined with the magnitude of the payment and lack of clarity around the scope of representation, raises serious questions about the authenticity, timing, and approval process of the invoice.

TESTIMONY

30) This summary of findings and analysis set forth my opinions, based on information currently available to me. I may supplement or amend this report based upon additional pertinent information.



Bell Canyon HOA - Forensic Accounting Timeline of Lawsuits [1]



 After the retainer date of February 8, 2023, any payments exceeding \$10,000 that were not approved by the Litigation Committee or the BoD are also considered unauthorized and are included in the totals above. It should be noted that during a Litigation Committee Metting on February 8, 2023 a motion to ratify all the legal bills over \$10,000 from 2022 was unanimously approved. See Exhibit 2. The ratification referred to a .Zip file that was presented to the committee. We have not received this file and cannot verify if the payments to Hudock were part of that file, nor are we able to state whether such a delayed and general ratification is valid, so for purposes of this analysis the payments over \$10,000 are considered unauthorized.
- [3] Assembly bill 2912, effective January 1, 2019, prohibited the automatic or electronic transfer of amounts exceeding \$10,000 or 5 % of the HOA's combined reserve and operating account.
- [4] Engagement letter between Bell Canyon Association and Hudock Employment Law Group was signed on February 8, 2023.
