HIGHWAY DEPT: Bryan Pedersen Highway Supt met with the Board. The used motor graders that were declared surplus will be advertised and sold on March 6 by sealed bids. The dept has more sand and salt mixed up ready for the roads. The railroad wanted more information on the overhead bridge project. The Engineer answered these questions. The Board set March 6 for the bidding of the yearly supplies for the road and weed dept. The Board also set Feb. 21 at 10:00 at the 4-H Building for the annual meeting with the township boards.

SEMI-ANNUAL COUNT OF CASH: Commissioners Noem and Saathoff did the semi-annual count of cash in the Treasurers Office.

PUBLIC COMMENT: No one appeared for public comment.

NURSE: Angela Hunter Public Health Nurse met with the Board. She stated that 906 food packages were issued from July-Dec. with an estimated food dollar of 53,900.37 She stated the State is starting a new program called Bright Start program for mothers who are pregnant . She attended substance abuse training, pregnancy care program review, vaping presentations and drug overdosing presentations. There are about 158 in the WIC program. She continues to cover WIC in DeSmet once a month. She also does developmental screenings for children. She provides school services to Estelline School and Poinsett Colony. She stated her office mgr Donna Eide is retiring Jan. 31 after 18 years of service to the County.

She has hired Jackie Kretzschmar as of Jan. 9 for this position. The Board thanks Donna for her years of service to the County.

WEED DEPT: John Michalski Weed Supervisor met with the Board. He submitted his annual report of spraying 191 hours for the State 188 hours for the townships and 168 hours for the County. They covered a total of 3666 miles of road ditches. He submitted the chemical inventory for the year. He requested permission to attend the Weed and Pest Conference in Huron on Feb. 15-17. He would attend three days and Larry Goebel Weed Board member would attend two days. This is required for both to attend in order to receive State grant money. The Board granted permission for such. He would like to surplus three pieces of equipment to be advertised for sealed bids. Motion by Tulson seconded by Saathoff to declare the following as surplus and to be sold with sealed bids: 1984 Chevy 1.25 Ton pickup Vin 1GCGD34J6EF310312, a 1985 Chevy 1.25 ton pickup Vin 1GCGD34J2FF300524, and a 1984 IHC Truck All members voting aye. BE IT RESOLVED by the Hamlin County Board of Commissioners to declare a snow emergency and BE IT FURTHER RESOLVED, WE, the Board of County Commissioners of Hamlin County respectfully petition the Governor of the State of SD to declare an emergency/disaster to exist in Hamlin County.
