HIGHWAY DEPT: Bryan Pedersen Hwy Supt met with the Board. Weight limits are on and he will continue to watch the roads with weather changes. The 1994 big loader was taken to Butler in Watertown to be checked and has had nothing serious in these years. It has 14,000 hours on it. The Dept is doing crack sealing. BRIDGE INSPECTION: Motion by Roe seconded by Tulson to authorize the Chairman to sign the Bridge Reinspection Program Resolution: WHEREAS 23 CFR 650 Subpart C requires initial inspection of all bridges and reinspection at intervals not to exceed two years with the exception of reinforced concrete box culverts that meet specific criteria. These culverts are reinspected at intervals not to exceed four years. THEREFORE Hamlin County is desirous of participating in the Bridge Inspection Program. The County requests SDDOT to hire IMEG for the inspection work. The state will pay 80% of the cost and county 20%. All members Voting aye. Motion Carried. Randall Rudebusch Chairman

PUBLIC COMMENT: EMERGENCY& DISASTER: Brett Schutt Emergency & Disaster Mgr. met with the Board. He was requesting permission to apply for a grant through First District for mitigation. Cost is \$7500.00 but the grant will pay part and they will use the county dues for the rest so no more cost to county. Motion by Noem seconded by Saathoff to apply for such. Radio coverage in the Bryant area was discussed. He has been working with Two Way concerning this.

PUBLIC COMMENT: Cheslie Gustafson Janitor met with the Board. She went over how the furnace filter systems works which is not good. Commissioner Rudebusch will check with another company concerning this. She stated all the new toilets in the courthouse have been installed except for one on third floor which will be done this week. Her computer is quite old and will not work. She needs a laptop which she can control heat and cooling in the courthouse. The Board stated to look for one and can go up to \$1500.00 on such.

EXTENSION: Abbi Steek 4-H advisor met with the Board. She requested permission for her and Krista Haug Sec. to attend the spring conference in Brookings March 13-14 and in Mitchell on April 8 for training. The Board approved such. She is checking into getting a state vehicle which would charge .22 per mile rather that putting in mileage to the counties for her own vehicle. She has talked to Kingsbury County on this also but will do more checking of such.

WEED: John Michalski Weed Supervisor met with the Board. He presented the bids for weed chemical the County had received. Only bid received was from Nutrien Solutions for \$51.10 for Tordon 22K. State bids on chemical is one chemical Tordon 22K would be \$50.22 Codington County had a bid for \$53.45 on such. Motion by Roe seconded by Saathoff to accept the state bids on chemical which ever is the lowest. Bids could possibly change during the year. All members voting Aye. Motion Carried. Complete listing of all chemicals available for inspection at the Auditors Office. He stated the annual Weed and Crop Improvement meeting will be held on March 11 in Hayti.

EXECUTIVE SESSION: Motion by Tulson seconded by Noem to go into executive session at 10:45 for personnel reasons SDCL 1-25-2 (1) All members voting Aye. Motion Carried. The Chairman declared them out at 11:05

SHERIFF: Chad Schlotterbeck Sheriff met with the Board. He stated every five years the bullet proof vests have to be replaced at a cost of about \$1200.00 per vest. They would need six vests. He stated usually this time of the year the company will give a 10% off which he will keep checking on. There are no grants available for this. The Board approved the purchase. He also stated they had received a grant of \$4500.00 for 24/7 program. They need to get two new computers for 24/7 and for Lt Tayt Alexander, Total Cost would be \$3643.67 which is all set up with programs and information in it. This will all come out of 24/7 funds. The Board approved such. He would like to send Cheslie Gustafson to training for 24/7 which she handles a lot of this even after hours. He would like to see an increase in salary for this. No action taken by the Board on this.

LAKE NORDEN MAYOR: John Layman Lake Norden Interim Mayor met with the Board to introduce himself and stated he wanted to have a good working relation with the County. He talked about the progress of the new buildings for the Fire and Ambulance departments which should be ready by the middle of April.

GOLF CLUB ROAD: Joe Jensen discussed the township road pass the golf club which he would like to see something done to the sides on the road.

COURTHOUSE CLOSING: The Courthouse will observe the State closing of March 29 and April 1 for the Holiday.
