WEED STATE CONTRACT: Cody Michalski Weed Supervisor met with the Board. He presented a contract with the SD Dept of Transportation to spray ditches on state roads at the rate of 110.00 per hour plus chemical cost for an estimated revenue to county of 24,780.00. He stated this was comparable to other counties doing state spraying. Motion by Saathoff seconded by Noem to authorize the Chairman to sign the contract with the DOT. All members voting aye. NURSES CONTRACT: Motion by Noem seconded by Roe to authorize the Chairman to sign the yearly contract with the SD Dept of Health for a full time state employed nurse for Hamlin County at the rate of 7097.76 per year. All members voting Aye. Motion Carried.

NEW HIRE: the Board approved the hiring of James Benning in the Director of Equalization office at the rate of 4250.00 per month and if training at night or weekends 25.00 per hour, also the hiring of Jamie Lantgen in the Director of Equalization office at the rate of 3750.00 per month and Stacey Lickfelt for temporary assistance at the rate of 18.00 per hour.

24/7 Salary: The Sheriff had requested an increase in pay for Cheslie Gustafson who handles the 24/7 program through his office for approximately 20 hours a month. The 24/7 program had received a grant of 4500.00 for salaries. The Board approved an hourly salary for her for 24/7 work of 20.00 per hour.
