UNAPPROVED MINUTES: The Hamlin County Board of Commissioners met on April 2,2024 with the following members present: Noem, Tulson, Saathoff and Roe. Absent Rudebusch. John Delzer States Attorney was also present.

The Vice Chairman led the Board in the Pledge of Allegiance.

AGENDA: Motion by Saathoff seconded by Roe to approve the agenda as posted. All members voting Aye. Motion Carried.

MINUTES: Motion by Tulson seconded by Saathoff to approve the minutes of March 20,2024 All members voting Aye. Motion Carried.

HIGHWAY DEPT: Bryan Pedersen Hwy Supt met with the Board along with Ben Stout who was representing the new dairy being built by Castlewood and also present Josh from IMEG. Discussion was held on the turning lane proposed by the dairy entrance on the county highway. Ben would like permission to apply for a grant through the Dept of Transportation Agri-Business Access Grant Program through the County from the State for these costs. Would be about \$600,000 applied for. IMEG will start with the engineering of such and estimated final figures so the grant can have these figures to work with. This grant has to be in April 15, 2024 to the State or will have to wait for the next application period of July 15, 2024. The county will receive all the sales and excise tax from the State from this dairy which Ben will apply quarterly for. He thinks this will be about \$1,000,000 from this. He needs the Board to approve filing for the grant. Motion by Roe seconded by Saathoff to apply for the grant. All members voting Aye. Motion Carried. Ben stated he will meet with the Board after the final figures are established. Then they will also decide when the turning lane can be done. Bryan stated the bridge northwest of Estelline was again denied by the State. Josh discussed costs for trying to get the points higher but the point system keeps changing. To get this bridge bid ready would cost the county about \$310,000.00 and no guarantee that the County would receive anything from the State. Josh stated he inspects this bridge and it is still doing fine just weight limited.

PAVEMENT MARKING AGREEMENT: The Transportation Commission approved an annual payout of the state funding set aside for county pavement marking starting in 2024. Counties will receive a proportional share of this based on the SDDOT certified road mileage for Hamlin County which in 130.367 miles. This payment will be sent with the annual STBGP payout effective for the next 15 years. Motion by Saathoff seconded by Roe to authorize the Chairman to sign such. All members voting Aye. Motion Carried.

Ordinance #2024-1: Second Reading was held to consider Ordinance #2024-1, an Ordinance amending Section 3.07.10 Area Regulations (Lake Park District and replacing Chapter 3.11 Flood Plain Overlay District with Chapter 3.99 Floodplain District in Article 111 District Regulations. No comments were received. Motion by Saathoff seconded by Roe to adopt such Ordinance. All members voting Aye. Passed and adopted this 2nd day of April 2024
