May 9,2023

UNAPPROVED MINUTES: The Hamlin County Board of Commissioners met on May 9,2023 with the following members present: Rudebusch, Saathoff, Tulson, Noem and Roe. No one absent. Also present was John Delzer States Attorney.

The Chairman led the Board in the Pledge of Allegiance.

AGENDA: Motion by Noem seconded by Saathoff to approve the agenda as posted. All members voting aye. Motion Carried.

MINUTES: Motion by Roe seconded by Noem to approve the minutes of April 18,2023 All members voting aye. Motion Carried.

HIGHWAY DEPT: Bryan Pedersen Hwy Supt met with the Board. Also present were two engineers from IMEG, Dallas Bochek, Randy Taschner, and Robert and Elaine Rommereim. Bryan presented an application for boring. Motion by Roe seconded by Noem to authorize the Chairman to sign the boring application for drainage 8" yelamine for Basin Construction for Brian Kuhlman Section 17-115N-53W of County Road 450 Ave. All members voting aye. Motion Carried. The Board declared a Balderson Snow Wing Standard(code 8814) as surplus and to sell it to Brule County for 1500.00 All members voting Aye. Motion Carried. Northern Truck has a new 1500 ft stainless steel sander for sale for 24,250.00 The old one is destroyed. Motion by Roe seconded by Saathoff to purchase this sander. All members voting aye. Motion Carried.

Bryan stated the County had received their annual STBGP payment from the State of 184,455.25 for road and bridge maintenance, repair and reconstruction. They also have received 116,900.00 from Butler for purchase of two used motorgraders from the County. Engineers from IMEG met with the Board . They made a proposal for engineering services for STR NO 29-277-140 Hydraulic Analysis for 18,000.00 to determine the size of a box culvert for this site. This would be better to qualify for the State grant , would cost less and last longer. This would be a poured in place 5-6 barrel culvert. Motion by Saathoff seconded by Tulson to accept this proposal. All members voting aye. Motion Carried. John Delzer States Attorney submitted easements for the railroad for the removal of the overhead bridge. Approximate cost could be 7500.00 Motion by Noem seconded by Roe to authorize the Chairman to sign these easements and to allow the Auditor to make such payment when required. All members voting Aye. Motion Carried. Dallas Bochek stated his son was able to get the railroad to put in a new culvert.

BIDS FOR CRUSHED GRAVEL: As advertised bids received for purchase of ¾" crushed road gravel Nitteberg Construction 5.55 per ton, Bowes Construction 5.25 per ton at Pedersen Pit, Brownlee Construction 6.75 at Codington County Pit. Motion by Saathoff seconded by Tulson to accept all three bids due to location of pit and location of project. All members voting Aye. Motion Carried.

PUBLIC COMMENT: Dallas Bochek, Randy Taschner and Robert & Elaine Rommereim stated they would like to have the water pumped off of 188 St. Water is about 24 inches deep now. They feel this water could be pumped to a drainage ditch to the south. Taschner stated he had received a quote last year for pumping of around 69,000 to rent equipment or 119,000 if the company did it themselves. They feel people are in agreement for this. They feel for the school and farming this is necessary. The Board stated they would have to have signed agreements with all the people affected. The engineers stated this would be required all the way down to the lake. Some suggested a permanent pipe be put in rather than having to pump again. This will be checked on cost.

STRIPING AGREEMENT: Motion by Saathoff seconded by Tulson to authorize the Chairman to sign the Joint Powers Agreement for the DOT to provide for the striping of about 38 miles of county roads The State will pay up to 12,195.96 of cost and the county will pay up to 8130.64 of cost . All members voting Aye. Motion Carried.

VETERANS SERVICE: David Schaefer Hamlin Co Veterans Service Officer met with the Board. He stated for 2022 Hamlin County Veterans had received a total of 3,983,000.00 in benefits with 353 veterans receiving assistance. He stated Hamlin County does not have a transportation program because the county's population is too high to qualify for the grant. If received it would require all volunteer trained drivers which is very difficult to get.

SHERIFF: Tayt Alexander Deputy Sheriff met with the Board. Their department has been contacting the schools in Hamlin County concerning a resource officer program which would be for two hours each week in each school. Cost with them paying for such. They currently do 6 hours in Castlewood School. He applied for a grant to fund such but was denied. They will keep meeting with the schools.
