Also hiring of James Benning for Deputy Director of Equalization at \$51,000 per year. All members voting aye. Motion Carried.

ORDINANCE 2024-2: First Reading of Ordinance #2024-02 amending Section 3.07.11 Structure Regulations Lake Park District updating lot coverage percentage. No comment was received.

HIGHWAY DEPT: Bryan Pedersen Hwy Supt met with the Board. Bryan stated IMEG will be doing the engineering for the turning lane by the dairy and wants to submit the bill to the County which then the State grant will reimburse the County for such. Moving the county patrol shed from Lake Norden to Hayti would cost about \$15,000 It is about 50x30 Lake Norden needs the lot it is on which is owned by the County. He had done the road part for the railroad crossing by the overhead bridge project. The railroad stated the signs must be different color than what he had put up, so will change them. With the truck grant for replacement, the new truck should be in Aberdeen by June and to the County by Oct. Aberdeen is putting the box on it. The dept has been putting culverts in and graveling. Commissioner Saathoff wanted some holes patched south of the C Store by Estelline. They requested to have the water level on 188th monitored. The two Norden Township officers were requesting help for the Golf Course road which is a township road.
