No one absent. Also present was John Delzer States Attorney, Stephanie & Jerry Sauder, Riley Buck Scott Popham, Jenna Aderhold, Reporter, and Sara Frankenstein.

The Chairman led the Board in the Pledge of Allegiance.

AGENDA: Motion by Noem seconded by Roe to delete the reading of Ordinance #2024-04 until the Oct meetings and to put Jessica Tesch, Zoning Officer in that time slot, and then to approve the agenda. All members voting Aye. Motion Carried.

PETITIONS: Sara Frankenstein Attorney, talked about the petitions that had been given to the County. She went over what they meant. Stephanie Sauder stated her race had a recount in six counties and all the ballots hand counted in the six counties agreed with the machine counts.

SURPLUS: Motion by Tulson seconded by Roe to declare a 2002 John Deere Gator 6X4 from the Weed Dept as surplus and will be sold by sealed bids received by Oct 8, 2024 at 10:30 am All members voting Aye. Motion Carried.

HIGHWAY DEPT: Bryan Pedersen Hwy Supt met with the Board. The County had a temporary easement with Lyman Hanson for 9.37 acres which could not be farmed while the overhead bridge project was going on. Bryan asked that the Board authorize the payment of \$2,342.50 for the use of the temporary easement. Motion by Noem seconded by Saathoff to make this payment. All members voting Aye. Motion Carried. Bryan presented a change order from Basin Construction with what they had put over the land area was a different product than bid so they are lowering their cost from \$135,000 to \$120,124. Moton by Roe seconded by Noem to approve this change order. All members voting Aye. Motion Carried.
