UNAPPROVED MINUTES: The Hamlin County Board of Commissioners met on Oct 3,2023 with the following members present: Rudebusch, Tulson, Noem and Roe. Absent: Saathoff Also present was John Delzer States Attorney, Casey Witt, Daryl Rust and Betty Skroch members of Norden Township Board, and Ben Stout .

The Chairman led the Board in the Pledge of Allegiance.

AGENDA: Motion by Roe seconded by Noem to approve the agenda as posted. All members voting aye. Motion Carried.

MINUTES: Motion by Tulson seconded by Noem to approve the minutes of Sept 19,2023 All members voting Aye. Motion Carried.

HIGHWAY DEPT: Bryan Pedersen Highway Supt met with the Board. Ben Stout representing the Czech dairy discussed the turn lane on the County Highway. The grant he is applying for through the State for the road work would have to be in to the State by Oct 15 and dairy work done by Nov .The grant is only good for a certain period of time. He feels it would be better to wait until spring to apply after dairy complete for the grant which would reimburse the County. The Dairy should be in operation by Jan. 2025 The Board agreed this sounded like a good idea. Bryan stated the State has closed Hwy 25 from Bryant intersection to the Willow Lake road so some trucks are now using 438 Ave. Everything is complete with the railroad for the overhead bridge project. The State will let the bid letting for Dec. 6,2023 for the removal of the bridge. The construction part for the road will be let by the county sometime in Jan.

PUBLIC COMMENT: David Schaefer representing the Hayti Legion Post requested if the Legion could hold their annual poultry party on Nov. 11 at the 4-H building which would give them more room. Motion by Noem seconded by Tulson to approve such and stated there would be no rental charge for the Legion to use it. All members voting Aye. Motion Carried. Jessica Delzer Treasurer also met with the Board during this time to request to hire Jolene Wilhelmsen as a full time deputy in her office starting Oct 23. The Board approved the hiring of the deputy at the rate of 17.85 per hour. Also during public comment Daryl Rust and Betty Skroch representing Norden Township Board discussed the three miles of 193rd township gravel road because of so much travel on it. Casey Witt also went over a development he is working on in that area.

NEW HIRE: The Board approved the hiring of Donna Rhody Deuel County Director of Equalization to assist on weekends and nights the Director of Equalization office due to the position being vacant at this time. The rate for her will be 45.00 per hour.

MITIGATION GRANT: Kingbrook Rural Water System is requesting permission to apply for a mitigation grant for a generator for the Stormo Booster Station because in the event of utility power failure, this station does not operate 95 users would lose water service and estimated 3420 head of cattle or livestock units would lose water service as well. Estimated cost 107,000 and engineering 41,000 No cost to the County. Motion by Tulson seconded by Noem to allow them to apply for such. All members voting Aye. Motion Carried.

FIVE YEAR ROAD PLAN: Motion by Noem seconded by Roe to pass a Resolution adopting the Hamlin County Five Year Highway and Bridge Improvement Plan. All members voting Aye. Motion Carried. WHEREAS, the SD DOT Local Bridge and Improvement Grant Fund requires that in order to be eligible to apply for Bridge Improvement Grant funds, Counties are required to develop a five year Highway and Bridge Improvement Plan, hereinafter referred to as Plan; and WHEREAS, Hamlin County has utilized the SD DOT, County Staff, the First District Assoc. of Local Governments, Townships and the general public in developing the various components of the Plan and WHEREAS the Plan includes maps and lists identifying an inventory of highways and bridges, project needs and revenue sources and WHEREAS, Hamlin County held a public meeting on Sept 19,2023 to solicit input into the Plan, and the citizens who attended expressed an interest in the Plan; and WHEREAS, the County will be able to use the plan as a tool to budget for transportation enhancements and better coordinate transportation issues with other entities; NOW THREFORE BE IT RESOLVED BY THE HAMLIN COUNTY BOARD OF COUNTY COMMISSIONERS THAT THE HAMLIN COUNTY FIVE YEAR HIGHWAY AND BRIDGE IMPROVEMENT PLAN IS HEREBY ADOPTED AND IS RECOGNIZED AS THE HIGHWAY AND BRIDGE IMPROVEMENT PLAN FOR HAMLIN COUNTY.
