Minutes:

UNAPPROVED MINUTES: the Hamlin County Board of Commissioners met on Sept 2,2025 with the following members present: Rudebusch, Saathoff, Tulson, Buck and Popham. No one absent. John Delzer States Attorney also present.

The Chairman led the Board in the Pledge of Allegiance.

Agenda: Motion by Saathoff seconded by Tulson to approve the agenda as posted. All members voting Aye. Motion Carried.

MINUTES: Motion by Buck seconded by Popham to approve the minutes of August 19,2025 All members voting Aye. Motion Carried.

HIGHWAY DEPT: Bryan Pedersen Hwy Supt met with the Board. Duininck will start the new mat Sept 17; Bryan had talked to the State concerning the grants for the turning lane. The State said they could not be used for anything else. The Dept has put a 70-foot-wide approach for dairy and has been putting on gravel. Asphalt will be put on the highway by dairy. Bryan stated the motor grader by Hazel had the transmission go out of it. Butler Machinery will charge \$30,000 to fix Clutch 5. It will check that when they tear it apart to see if they have to do the whole transmission. If they do the whole transmission the cost would be \$67,000 which includes a warranty for 3,600 hours. Butler will see if just doing the clutch will work. The dept is hauling gravel and has finished the top cut of ditches. Gerhold's has been looking to fix the crossing apron on one side by Vetter's. Other side has been done.
