UNAPPROVED MINUTES: The Hamlin County Board of Commissioners met on Nov. 19,2024 with the following members present: Rudebusch, Noem, Tulson, Saathoff, and Roe. No one absent. Also present was John Delzer States Attorney, Scott Popham and Riley Buck.

The Chairman led the Board in the Pledge of Allegiance.

AGENDA: Commissioner Tulson would like to see added discussion on grants to receive and sales tax and excise tax. Motion by Saathoff to approve the agenda as posted with the addition of Tulsons request. Seconded by Roe. All members voting Aye. Motion Carried.

MINUTES: Motion by Noem seconded by Saathoff to approve the minutes of Nov. 7,2024 All members voting Aye. Motion Carried.

HIGHWAY DEPT: Bryan Pedersen Hwy Supt met with the Board. Commissioners Noem and Tulson had called Pierre concerning the County receiving the sales tax and excise tax for the dairies and hog buildings being constructed. They thought maybe someone from Pierre would call during the meeting. Also the two grants applied for the turning lane by County Line Dairy have been sent in by IMEG. The State has sent for more information on such which between IMEG and Ben Stout they will complete. Discussion was held about cost of State specifications and local specifications on these projects and this will be discussed when the County hears what the State is doing with these grants. Bryan stated the snow plows have been put on and the pile of salt sand is ready. He stated the last bill for the railroad of 37,972.10 had been received for the overhead bridge removal project. The Board asked for a report of all costs with the overhead bridge project.

PUBLIC COMMENT: No comment was received.

EXTENSION CONTRACT: Motion by Saathoff seconded by Roe to authorize the Chairman to sign the Memorandum of Understanding between SDSU and Hamlin County for payment of 11,525 for the year 2025 for a 4-H Advisor in Hamlin County. All members voting aye. Motion Carried.

CONTINENCY BUDGET TRANSFER: Motion by Saathoff seconded by Tulson to transfer from Continency Budget 40,000 to the Jail Budget. All members voting Aye. Motion Carried.

LIQUOR LICENSE RENEWAL: Motion by Tulson seconded by Saathoff to approve the renewal of a retail on sale liquor license for Bobbers. All members voting aye. Motion Carried.

WEED STATE GRANT: Motion by Roe seconded by Saathoff to make an automatic supplement to the Revenue Budget (101-334) for 6100.00 for a state weed grant received. All members voting Aye. Motion Carried.

PLAT: Motion by Noem seconded by Saathoff to approve the following plat of Gjerde Yard Addition Located in the Southwest Quarter of Section 29, Township 115 North, Range 54 West of the 5th PM Hamlin County SD All members voting Aye. Motion Carried.
