UNAPPROVED MINUTES: The Hamlin County Board of Commissioners met on August 19,2025 with the following members present: Rudebusch, Saathoff, Tulson, Buck and Popham. No one absent. John Delzer States Attorney, T.J. Middlebrook, and Jenna Aderhold reporter were also present.

The Chairman led the Board in the Pledge of Allegiance.

AGENDA: Motion by Buck seconded by Saathoff to approve the agenda as posted. All members voting Aye. Motion Carried.

MINUTES: Motion by Tulson seconded by Popham to approve the minutes of August 5, 2025 All members voting Aye. Motion Carried.

HIGHWAY DEPT: Bryan Pedersen Hwy Supt met with the Board. During the past weekend there was flooding on the east side of the County. As of today all roads are clear of flooding. The Blade patching of hot mix is done. He requested to rent a tractor for mowing the road ditches from Eastside Equipment for 25.32 per hour for up to 200 hours. Board approved such. The spillway by Vetters one side is fixed and culverts were put in. Bryan has got someone to fix the other side. The Dept is hauling gravel and will make a top cut of ditches. Waiting with chip sealer for J&L to make a part that was broken.

BID LETTING: Mat Construction for County Road 464 (4 miles) Approximately 6650 tons. Mobilization needs to be included. Duininck Inc Per Ton 86.25 total \$573,562.50 Bowes Construction 89.50 per ton total \$595,175.00 Mat Construction on County Road 459 (.3 mile) approximately 450 tons. Mobilization needs to be included in the per ton price. Bowes Construction 97.50 per ton total \$43,875.00 Duininck Inc. 130.00 per ton total \$58,500.00 Motion by Saathoff seconded by Popham to accept the bid of Duininck Inc for both bids due to total being the least. SALARY CHANGE: The Board approved effective August 1, 2025 for Felicia Lowe Deputy Sheriff salary of \$25.00 per hr.

MEMORANDUM OF UNDERSTANDING: Motion by Buck seconded by Tulson to authorize the Chairman to sign the Memorandum of Understanding between SDSU and Hamlin County. All members voting aye. Motion Carried.

PUBLIC COMMENT: T.J. Middlebrook stated there will be a meeting in Goodwin for people to attend listening about doing away with property taxes. He has let township officers know about this also. He also stated that Dakota State does checking of computer systems for free concerning computer security.

VETERANS SERVICE: Jay Roberts Veterans Service Officer and Eric Lewis Deputy Veterans Service Officer met with the Board. He stated Hamlin County has 17 open working claims with 11 completed claims. Increase in monthly compensation for veterans or their dependents. Year to date retro payments are \$211,461 to bring claims current. The SOG Veterans Information Event in July was a successful event. Thirty two veterans along with spouses attended such. Veterans/Military Appreciation Event will be held at Joy Ranch Nov. 8, 2025 with a free lunch.
