UNAPPROVED MINUTES: The Hamlin County Board of Commissioners met on March 4,2025 with the following members present: Larry Saathoff, Burt Tulson, Riley Buck and Scott Popham. Absent: Randall Rudebusch. Also present was John Delzer States Attorney and Jenna Aderhold reporter.

The Vice Chairman led the Board in the Pledge of Allegiance.

He stated the company out of Sioux Falls can no longer sell the product for sealing cracks in road. It will have to come from a company in Minnesota. 188th Street 10½ miles west is 2/3 out of water presently. Middle part still probably 3-4 inches of water.
