UNAPPROVED MINUTES: The Hamlin County Board of Commissioners met on June 3,2025 with the following members present: Rudebusch, Saathoff, Tulson, Buck and Popham. No one absent. Also present was John Delzer States Attorney and Jenna Aderhold reporter.

The Chairman led the Board in the Pledge of Allegiance.

AGENDA: Motion by Saathoff seconded by Buck to approve the agenda as posted. All members voting Aye. Motion Carried.

MINUTES: Motion by Buck seconded by Tulson to approve the minutes of May 20, 2025 All members voting Aye. Motion Carried.

HIGHWAY: Bryan Pedersen Hwy Supt met with the Board. He stated he had measured for the mat overlay project and has advertised for bid letting to be held on June 16,2025 Bid letting material has been sent out to various companies. The Dept has been repairing some roads by digging down and packing such before repairing the top part. The bridge that had been damaged by a vehicle will be repaired. All the material for such has arrived. The County will paint such after that is finished. SD Public Assurance will come to the highway shop on Monday free of charge to present training for all the employees on blade operation. Estelline Township will also send their blade operator for the training. 188th ST 10 ½ miles west is still under about 10 inches of water. He has replaced new reflective signs there because old ones had been destroyed. Ben Stout will be meeting with landowners concerning easements for the turning lane for the County Line Dairy project.
