Minutes:

UNAPPROVED MINUTES: The Hamlin County Board of Commissioners met on April 3, 2025 with the following members present: Rudebusch, Saathoff, Tulson, Buck and Popham. No one absent Present also were 20 county residents.

The Chairman led the Board in the Pledge of Allegiance.

APPROVE AGENDA: Motion by Saathoff seconded by Buck to approve the agenda as posted. All members voting aye. Motion Carried.

MINUTES: Motion by Buck seconded by Popham to approve the minutes of March 18,2025 All members voting Aye. Motion Carried.

HIGHWAY DEPT: Bryan Pedersen Highway Superintendent met with the Board. He stated that the State will be closing the state highway east of Estelline City on April 8 for road work.

He stated the price for a printer for the new loader is \$3,500.00 and for installation about \$500.00. It weighs the loads and also records all things done. He stated he is unable to install such since it is like a computer program. Motion by Buck seconded by Popham to approve the purchase of such. All members voting aye. Motion Carried.

Adam from IMEG engineering met with the Board. He stated the turning lane for the County Line Dairy would take about 50 feet on the west side which the dairy owns and it would donate this for the work. IMEG showed a plat showing Lot H1 in the NE ¼ of Section 2, Twp 115N Range 52 west with the plans for such. Motion by Saathoff seconded by Tulson to authorize the Chairman to sign the Highway Use Deed signed by Dairy to proceed. All members voting Aye. Motion Carried.

The highway department will chip seal when product is available. Usually wait 5-6 years after an overlay so it will dry out. Weight limits are still on.

He stated he will be bidding 5 miles straight east on 188th St off of Hwy 81 and some other places to go along with it for bidding purposes.

GRAVEL PIT: Grant McDaniels pit operator and two other workers from Basin Construction were also present for questions on opening a gravel pit. About 20 neighbors were present for this. They were not notified of the pit due to a zoning rule of this property having a 100 foot buffer around it so only that person whose land it is was notified. They feel that should be changed in zoning rules. Basin stated they will watch old hwy 81 and could chip seal if necessary. They will also talk to the DOT about an approach for the pit. The residents are concerned with 186th Street and safety of pulling out or in to such off of Hwy 81 with the truck traffic. They suggested signs of entering trucks and turning be posted by the DOT farther ahead so drivers would be able to be aware of traffic stops ahead. Neighbors would like to see that 186th Street would not be used for safety. The group would like zoning to look at this rule. Also they were requesting that all publications for zoning be posted where they can look at them because they do not get the newspapers for notices. They felt the end could be widen also for incoming traffic. Basin and DOT will keep John Bucher informed so he can let neighbors know what is happening. John Delzer States Attorney now present.

AG BUILDING: Abbi Steeke, 4-H Advisor met with the Board. She had a quote of installing the cabinets and counter tops at the 4-H Building from Cons Construction for \$3,620.20 Motion by Tulson seconded by Buck to proceed with ordering cabinets and this installation. All members voting Aye. Motion Carried. She requested permission for her and Krista Haug Secretary to attend a training in Aberdeen April 10 for her once a month to attend a meeting in Watertown. The Board approved such.

LEGISLATOR: Kent Roe Legislator met with the Board to give them updates on laws that were passed and work done in legislature this past session.

Commissioner Buck left the meeting at 10:45.

FIRST READING ORDINANCES: ORDINANCE 2025-01 Common Ownership, Ordinance 2025-02 Agricultural Truck Wash and Car Wash, Ordinance 2025-03 Members of Zoning Board from seven districts to be the same as the Commissioners Districts. No comments heard.

PLAT: Motion by Saathoff seconded by Tulson to approve the plat of Limmer Addition in the County of Hamlin SD located in the Northwest Quarter of Section 18, T113N, R53W of the 5th PM Hamlin County. All members voting Aye. Motion Carried.

HOLIDAY CLOSINGS: The Governor has given Friday April 18 and Monday April 21 as holidays for workers which the courthouse will be closed both days.

AUTOMATIC SUPPLEMENT: Motion by Saathoff seconded by Popham to make an automatic supplement to the Revenue Source 20.600 for \$200.89 and to the Sheriff's Budget 101-211-411 for \$153.53 for Highway Safety Grant Reimbursements All members voting Aye. Motion Carried.

SHERIFFS GRANT: Tayt Alexander Lieutenant Deputy Sheriff met with the Board about a Highway Safety Grant for Oct 1-2025-Sept 30 2026 This would cover overtime of \$17,900 Radar Unit Grant \$2,400.00 County share \$685.00 Camera Hardware Equipment Unit grant \$3,871.66 County share \$967.92 Total grant would be 24,271.66 Motion by Tulson seconded by Saathoff to proceed with the grant application.
