UNAPPROVED MINUTES: The Hamlin County Board of Commissioners met on June 17,2025 with the following members present: Rudebusch, Saathoff, Tulson, Buck and Popham. No one absent. Also present was John Delzer States Attorney and Jenna Aderhold reporter

The Chairman led the Board in the Pledge of Allegiance.

AGENDA: Motion by Saathoff seconded by Tulson to approve the agenda as posted. All members voting Aye. Motion Carried.

MINUTES: Motion by Buck seconded by Popham to approve the minutes of June 3,2025 All members voting Aye. Motion Carried.

BIDS MAT OVERLAY: Project on County Road 450 Ave 3.1 miles and .6 mile Main Ave in Lake Norden. Grinding and lay mat of recycled material also three water shut off risers and 10 man hole risers. The training for motor graders operation put on by the Public Alliance Insurance went well. They will be putting gravel on some roads.
