UNAPPROVED MINUTES: The Hamlin County Board of Commissioners met on Nov. 7,2024 with the following members present: Randall Rudebusch, Douglas Noem, Burt Tulson, Larry Saathoff and Leland Roe. No one absent. Also present John Delzer States Attorney, Jenna Aderhold reporter ,Riley Buck, Ben Stout, Brantford Township board members: Harold Singrey, Timothy Fuerstenau and Jon Rider .

The Chairman led the Board in the Pledge of Allegiance.

AGENDA: Motion by Noem seconded by Saathoff to approve the agenda as posted. All members voting Aye. Motion Carried.

MINUTES: Motion by Roe seconded by Noem to approve the minutes of Oct 22,2024 All members voting aye. Motion Carried.

HIGHWAY DEPT: Bryan Pedersen Hwy Supt met with the Board. He presented an application for boring under road for drain tile. Motion by Tulson seconded by Saathoff to approve the boring application for drain tile for Claremont Colony in Dempster Township Section 13-R114 -51. All members voting Aye. Motion Carried. IMEG also presented a change order for Basin Construction on the 183rd St/438th Ave Reconstruction project in the amount of 17,589.00 additional. Motion by Noem seconded by Roe to approve the change order. All members voting Aye. Motion Carried. Bryan stated the air compressor which was bought in 1986 quit and no parts available. New motor would cost about 875.00 Ben Stout went over the turning lane project for County Line Dairy. Probable costs could be 379,899 or 261,557 depending on which one would be chosen. The State had changed what they would supply for their share. They had sent a grant application for infrastructure grant funds of 142,500 but not to exceed 26% of eligible project costs . These funds must be matched and are subject to application and approval from GOED's local infrastruture improvement program. DOT grant available also. Motion by Noem seconded by Tulson to apply for both grants but only accepted if both grants are received. All members voting Aye. Motion Carried. IMEG will make both of these grants to send to the State. All of this will depend on which costs are more suitable for the county. Ben stated to keep trying to get the sales tax money also from the State not only for this project but two more projects in the county. It was discussed with Brantford Township Board to vacate a road. The States Attorney will look into this.

The most reasonable one was a 2024 JI Mfg 82 x 102 Truck Bed for 3100.00 from Prairie Wind Humboldt and tank 111HEO500-57Y and skid 083 SKE500 from C&R Supply for 1895.00 Motion by Roe seconded by Tulson to have him purchase both. All members voting Aye. Motion Carried.

SUPPLEMENT COUNTY BUDGET: Hearing was held as advertised to supplement the Road Budget in the amount of 700,000 and to supplement the Operating Transfer Budget by 700,000 for the mat overlay project, road construction and the overhead bridge teardown project. No one appeared. Motion by Noem seconded by Saathoff to approve such supplement. All members voting Aye. Motion Carried.

ZONING: Jessica Tesch Zoning Officer for Hamlin County met with the Board. She stated one of the members of the zoning board was wondering about jurisdiction boundaries with cities and other

counties when close to them. Todd Kays First District Executive Director was present by phone. He stated this gets costly with variances and conditional uses. This has never been done before. The Board feels the rules stop at county lines.

PRE DISASTER MITIGATION:Luke Muller Senior Planner for First District met with the Board. First District is assisting Hamlin County in the update of the county's Pre-Disaster Mitigation Plan. This is required every five years in order to maintain eligibility for federal funding for disaster mitigation projects and other federal funding /programs. For the purposes of this plan municipalities and the county are considered participating units of government. This plan when finished is sent on to FEMA

TRAVEL: The Board approved the Treasurer, Auditor, Register of Deeds, Highway Supt, Highway Bookkeeper and Comissioners to attend the Sioux Valley Assoc. meeting in Redfield on Nov. 13

RESIGNATION: The Board accepted the resignation of Darrion Poppen Deputy Sheriff effective Oct. 27 and thanked him for his service.

CANVASS: The Board did the canvass of the General Election for all seven precincts with the poll books and results. This is then sent to the Secretary of State for their canvass on Nov. 12. The Board did the random drawing from all precincts and Norden Precinct was drawn and the state races of Public Utilities and Measure 28 for the post election audit.
