#### Minutes:

UNAPPROVED MINUTES: The Hamlin County Board of Commissioners met on Jan. 21, 2025 with the following members present: Saathoff, Tulson, Buck and Popham. Absent Rudebusch arrived at 10:30 Also present was John Delzer States Attorney, Jenna Aderhold Reporter, Toby from Butler Machinery.

The Vice Chairman led the Board in the Pledge of Allegiance.

AGENDA: Motion by Tulson seconded by Buck to approve the agenda as posted. All members voting Aye. Motion Carried.

MINUTES: Motion by Popham seconded by Buck with Buck making a change in the minutes of Jan. 7 for the Weed Dept purchasing a four wheeler not a three wheeler as stated and then to approve such with the change. All members voting Aye. Motion Carried.

HIGHWAY DEPT: Bryan Pedersen Hwy Supt met with the Board. Toby from Butler Machinery went over the quotes for machinery. He stated a new 962 Wheel Loader starting cost is \$531,777 trade in allowed 28,500 and with Sourcewell discount and Butler discount price would be \$354,277.82 which includes the warranty. Caterpillar Model 150JOY-BR Motor Grader new \$803,744.71 trade in allowed \$57,000 and with Sourcewell discount and Butler discount cost would be \$450,532.17 includes the warranty. Might be five to six months to receive such. Wheel Loader he only has spoken for one and would have to know right away or will not be saved.

BRIDGE REINSPECTION: Motion by Tulson seconded by Popham to authorize the Vice Chairman to sign the Bridge Reinspection Program Resolution for Use with SDDOT Retainer Contracts.

WHEREAS, 23 CFR 650 Subpart C requires initial inspection of all bridges and reinspection at intervals not to exceed two years with the exception of reinforced concrete box culverts that meet specific criteria. These culverts are reinspected at intervals not to exceed four years. THEREFORE Hamlin County is desirous of participating in the Bridge Inspection Program. The County requests SDDOT to hire IMEG Consultants Corp. for the inspection work. SDDOT will secure federal approvals, make payments to the Consulting Engineer for inspection services rendered and bill the county for 20% of the cost. The County will be responsible for the required 20% matching funds.

LOAD LIMITS: Motion by Buck seconded by Popham to pass the following

LOAD LIMITS RESOLUTION WHEREAS, THE County of Hamlin SD is responsible for the maintenance of certain highways under its jurisdiction, WHEREAS it appears that said highways, by deterioration, rain, snow or other climatic conditions will be seriously damaged or destroyed unless the use of vehicles thereon is prohibited or restrictions as to weight of vehicles are imposed and WHEREAS, the County of Hamlin lacks the scale equipment with which to enforce weight limits. NOW THEREFORE pursuant to SDCL 32-14-16 and any laws amendatory thereto, be it resolved that the load limit on Hamlin County asphalt road and some gravel roads within the County of Hamlin SD shall be 7 ton per axel. This resolution will be in effect for a full 75-day period. IT IS FURTHER RESOLVED that there shall be erected and maintained signs designating the provision of this Resolution as provided by State law and that the Resolution shall be effective until or unless such signs are erected and maintained. IT IS FURTHER RESOLVED that this Resolution be effective each and every year hereafter unless repealed or modified by duly enacted Resolution,

RURAL ACCESS INFRASTRUCTURE FUND: Dustin Leiseth representing the SD Township Assoc. spoke to the Board on how important this fund is for the townships to replace culverts. Townships must apply, have an OPT Out or Road Levy and have culverts of a certain size. Bryan has done an inventory of all culverts in the county and sent to the State. Townships are responsible for 20% of cost. In the last two years five townships have used this program. Hamlin County has received a total of \$360,051.19 for this program which has all been used. Dustin stated at this time the State has not allotted any more funds for this program. He is urging the County to send a letter in support of this program to the State Legislators to continue such program.
