UNAPPROVED MINUTES: The Hamlin County Board of Commissioners met on Oct 22,2024 with the following members present: Rudebusch,Noem,Tulson,Saathoff and Roe. No one absent. Also present was John Delzer States Attorney, Scott Popham and Jenna Aderhold reporter.

The Chairman led the Board in the Pledge of Allegiance.

AGENDA: Motion by Saathoff seconded by Roe to approve the agenda as posted. All members voting aye. Motion Carried.

MINUTES: Motion by Noem seconded by Tulson to approve the minutes of Oct 8,2024 All members voting Aye. Motion Carried.

HIGHWAY DEPT: Bryan Pedersen Hwy Supt met with the Board. He presented an application by Basin Construction for Paul Everson for a 10" yelomire boring on Township 115N- R53 Section SW 30 on 183 road. Motion by Saathoff seconded by Roe to approve the application. All members voting Aye. Motion carried. Bryan stated the paint striping is done on the new road where the bridge was taken down. He discussed the plans the DOT has for the state highway from Hayti to Lake Norden. This will probably be done in the year 2027 or 2028. He will attend a meeting in Hayti Oct 29 which the DOT is presenting some of their plans.

SURPLUS: The Sheriffs office has a vest used by Darrion Poppen which was bought in May for 1198.00 Darrion will be working for Brookings County and Brookings County will purchase such for 1000.00 due to the size of the vest which Darrion can use. Motion by Noem seconded by Roe to declare the vest surplus and to be sold to Brookings County for 1000.00 All members voting Aye. Motion Carried.

AUTOMATIC SUPPLEMENT: Motion by Roe seconded by Tulson to make an automatic supplement from Highway Safety Grants received for the Sheriff in the amount of 4668.56 to Sheriffs Budget Salaries 101-211-411 and to Revenue source grants 101-331.95 All members voting Aye. Motion Carried..

AUTOMATIC SUPPLEMENT: Motion by Tulson seconded by Saathoff to make an automatic supplement to the revenue source in General 101-374 for 1750.00 for the gator that was sold. All members voting Aye. Motion Carried.

CASH TRANSFER: Motion by Saathoff seconded by Noem to transfer cash of 1,500,000 from General Fund to Road Fund for the mat overlay project. All members voting Aye. Motion Carried.

CONTINENCY: Motion by Noem seconded by Roe to make a transfer of 100,000 from the Contineny Budget (101-112-429) to the Road Budget (201-311-425) for mat overlay project. All members voting Aye. Motion Carried.

HOLIDAYS: The Governor has given employees Friday Nov. 29 leave and Dec. 23 and Dec. 24 leave. The Board approved following the States closing as offices cannot get service from the State. Courthouse will be closed on those days.

PUBLIC COMMENT: Commissioner Tulson commented on contacting Pierre about the turning lane for the County Line Dairy and about available money.

ORDINANCE 2024-04: Second Reading was held on Ordinance 2024-04 to add temporary structures used for the sale of fireworks between June 27th and July 5 provided that there have been no past complaints or violations regarding previous sales. Motion by Saathoff seconded by Noem to adopt such Ordinance. All members voting Aye. Motion Carried.
