



## VOLUNTARY RELEASE, WAIVER OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT

This agreement waives any and all claims or liability against Unique Fishing Inc as a result of your and your child's or children's participation in any event held by Unique Fishing Inc PLEASE READ THIS CAREFULLY.
