**'UCCAANA Educational Endowment'
at Union Christian College**

Simon Thomas, Vice President, UCCAANA

1. Background

The UC College Alumni Association of North America (UCCAANA) is steadily growing in size and organizational stature. An element of its stated mission is to provide the College with encouragement and support for its renewal and growth in the contemporary world. Alumni can share their rich life experiences with their alma mater in its effort to extend its academic excellence and to offer a richer educational experience for the current and future generations. In addition to the spiraling cost of instruction in a highly competitive global environment, present day higher education also demands newer educational tools and techniques. A need exists to support highly talented students from disadvantaged socio-economic backgrounds. UCCAANA besides playing a key role in fostering intellectual and emotional connection with the College has an opportunity to provide supplementary financial support. With that in mind, one of the strategic goals of UCCAANA approved by its Board is the establishment of an endowment for sustained support of UCC in specific areas such as scholarships, modernizing science laboratories, newer teaching tools and methods, knowledge management resources, etc.

2. Overall Strategy

While sporadic donations to UCC have been made by very generous UCCAANA members, the need to provide a steady, sustainable, and predictable flow of funds to support academic activities was recognized by UCCAANA. An Endowment potentially can offer such a stream of funds not just for one year, or even one generation, but in principle for perpetuity and that steady flow will enable the College to make strategic investments in people and programs for the long term.

A portion of the earnings from such an endowment will be spent on specified projects on an annual basis (not the corpus that anchors the endowment), while the rest will be judiciously reinvested to keep pace with inflation and to avoid effects of potential recession in future years. The strategy is to ensure that the original fund will grow over time. The fund is open to new additions from UCC alumni and friends, thus further ensuring growth of the fund.

Reaching an endowment of even a modest size is a slow process. Rather than getting hung up on its exact target size upfront, it is felt necessary to take the first step in establishing the endowment and a process for its management. UCC alumni in North America who are recognized to be generous, loyal and dedicated to our alma mater will rise to the challenge.

The expectation is to start the endowment with about \$10,000 which has been donated by Dr. K.C. Chacko, the UCCAANA Advisor. The UCCAANA Board will drive an effort to build the fund to reach a modest level in the range \$50K-\$100K in the short term.

3. Types of Donation.

Donations made to the endowment might take different forms. These include outright cash gifts, gift pledges, securities, deferred gifts such as life insurance, bequest through wills, trust etc. UCCAANA will be happy to help in the appropriate type of donations to the fund. *All contributions made to the endowment through UCCAANA are tax exempt in the United States.*

4. Guidelines for the Use of Funds

A portion of the income from the endowment will be spent every year for academic purposes as decided by an Endowment Management Team. In view of the remarkable economic growth foreseen in India, a judicious use of investment instruments (not only the traditional 'savings account') can yield impressive returns. This offers a path to reasonable growth of the corpus as well.

Suggested uses of the income from the endowment include:

- General Scholarships for students, merit based or merit-cum need based.
- Laboratory instrumentation and methods
- New teaching tools and methods
- “Library” resources including online access to an expanded list of technical journals, reports etc.
- Endowment lecture series
- Any other educational project approved by the Endowment Management Team.

The UCC-established process and criteria will be used in selecting the recipients of awards.

The funds will be disbursed equitably and fairly without undue regard to any specific academic discipline or department.

The income from the endowment may not be used for the operating expenses of the ‘Alumni Office’ or on building construction projects.

5. Management Oversight

- The name of the Endowment will be: **“UCCAANA Educational Endowment.”**
- A management team (which includes the Manager, Principal and the Bursar of UCC and the President and Treasurer of UCCAANA) is responsible for managing the endowment assets. Assistance of professional wealth managers may be sought in the judicious choice of investment instruments, if net returns warrant it.
- The funds received from UCCAANA towards the Endowment will be under the Government of India umbrella certificate that already exists in UCC and which remains current.
- UCC will be responsible for ensuring tax-exempt compliance in India.

6. Reports and Communication

- UCC will provide a detailed utilization plan for specific projects to UCCAANA to

ensure compliance with UCCAANA’s tax status in the USA.

- The Endowment Management Team will strive to be good stewards of the fund and will provide timely reports on endowment performance and accomplishments to the UCCAANA Board, at least once a year.
- Alumni donors may wish to see what their gifts allowed UCC to accomplish/make a difference in the academic life in UCC. Specific facts and stories of how alumni gifts have changed the lives and educational experiences of the UCC academic community may be provided for wider communication to the alumni at large through the UCCAANA website, via email etc. This is expected to be inspirational and will further motivate potential donors.

7. Next Steps in Implementation

In order to provide structure to the Endowment, UCCAANA prepared a Memorandum of Understanding (MoU) between UCCAANA and UCC. The UCC Governing Board recently reviewed and approved the MoU for execution. UCCAANA will start the endowment with a seed fund of \$10,000. In the coming months, UCCAANA will appeal to the alumni and friends of UCC to contribute towards building up this endowment. Of course, no donation is too small or too large. I hope the association will be able to motivate the alumni, to give something back to our alma mater. That is a key element of UCCAANA’s stated mission and will be a wonderful achievement and a glorious legacy of the alumni.

Our Association has been slowly, but surely, moving forward since 2006, and more members are joining UCCAANA. Just last week a new member joined our Association, and found out that he was at UCC around the same time I was at UCC. So I contacted him, and to both of our surprise, we found out that we were together at the Holland Hostel for two years, and that in the 80's he lived just 30 miles away from me for about 8 years. We had mutual friends, but we simply didn't know each other. We seriously think that we might have seen each other at some Malayalee functions and didn't recognize each other.

In 2009 UCCAANA, with a donation of \$7000.00, supported U.C. College to obtain computers for the library and internet access to various journals. It is functioning well now, and both the students and faculty members are taking advantage of this newly available technology. Also, we donated \$15,000.00 to establish an International House, and later we decided to use the same for an educational endowment, as there are so many poor and needy students at UCC. Recently we donated \$250.00 to a needy student at UCC as she was several months behind in paying her mess fees. We are in the process of finalizing a Memorandum of Understanding (MoU) for the UCCAANA Educational Endowment, and adding another \$10,000.00 to the corpus of the endowment. So far we have pledges for \$5000.00 from alumni and friends. We hope to reach our goal of \$10,000.00 before college starts in June, and request the alumni to consider the needs of these poor students. All donations to this cause are tax deductible. In October, 2010 Dr. M. G. Sarngadharan, a member of the current Board of Directors, contributed \$1500.00 to the Vidwan P.G. Nair Endowment at the Malayalam Department at UCC. In 2010 Dr. Titus Mathews of Calgary, Canada was instrumental in establishing the Center for Study of Religion and Society at UCC. He has contributed \$7500.00 for this project so far, and has agreed to contribute another \$2500.00 for this project.

Essay

Decaf, s'il Vous Plait!.....

[Suggestion: Read the essay entitled "Coffee Manager" which appeared in the UCCAANA Newsletter in the January, 2010 issue.]

I was not joking, the decision that I had made as regards my coffee drinking habits at the office (the lack thereof, really...) which I have described in my last essay happens to be real. As a matter of fact, that was one of my new year resolutions of yesteryear. I had resolved a few years back that I will not drink *office* coffee for as long as I live. Now, have I not made other new year resolutions before? Yes. And have I kept them? Not really! Most of my resolutions lasted about a couple of weeks, and were promptly broken by the time Martin Luther King's Birthday rolled around in mid-January. A few others got a little better mileage, but they too never lasted beyond the Presidents' Day. But when it came to my decision about not drinking the *office* coffee, there was a major difference. On a good day, I could sit down at my desk for about 15 minutes and eat a sandwich, although on most other days, it was lunch on the run. If I remember correctly, most everybody, including our beloved "Coffee Manager", was out during the Christmas and New Year holidays, and only a handful of us were left at the office. This necessitated that one of us do the honors, and as usual, I was volunteered (the passive voice is intentional) to be the "Guy-in-Charge" of coffee. Well, since I was volunteered, I decided to have the dubious distinction of fetching the water from the bathroom in the old yellow jugs, although I probably could have delegated that responsibility to my assistant manager, but there was one problem: There was no assistant manager! If there were one, I hadn't seen him, because he too was probably on vacation! So, off I go to the men's room with the yellow milk jugs in tow.

India's Department of Science and Technology Awards Rs. 5 million to U C College

The Department of Botany of the U C College will be receiving Rs. 4.96 million for the development of a Plant Molecular Biology laboratory under the Government's FIST (Funds for Improving the Science and Technology infrastructure in higher educational institutions) program. The grant will also help the establishment of a Computer lab, according to Dr. Thara Simon, one of the Advisors of UCCAANA. This year, the U C College is one of only 12 colleges in India selected for such an award. Simon went on to state that the Department of Chemistry of UCC received such a grant last year.

Union Christian College has a unique place in the hearts and minds of many of its students. I always wondered what made UCC have such an impact on many of us. Certainly it is not just the academic excellence which it always maintained. There were many other colleges in Kerala which were equally good or even better. I just want to share a few of my thoughts on the endearing and enduring qualities of UCC which made it a unique institution and hope to write a more detailed account sometime in the future. These are entirely my thoughts and reflections based on my experience and may or may not reflect the experiences of all the readers of this column.

The College was started in 1921 by four former Professors of Madras Christian College, whose names I am sure are well known to most of us. They were inspired by the ideals by which Madras Christian College was founded. The idea of the founders of UCC was to impart knowledge, high moral values, and patriotism, and mold students as responsible citizens. They also envisioned an enlightened student body with a broader outlook on life through residential life which also helped students foster close friendship among themselves irrespective of caste, creed, ideology and social status. The College also provided for coeducation in an ideal and healthy environment which was a model for other colleges. The residential life promoted a healthy student-teacher relationship. I can go on and on with a litany of personal accounts and stories which will attest to the wonderful and endearing aspects of UCC life, but as stated earlier, I hope to do that at some other time in the future.

UCC had eminent professors from diverse religious backgrounds who were highly respected and loved by their students and the faculty. Extracurricular activities were given a lot of importance which helped the students build sportsmanship, team spirit and character. The founding fathers with high ideals, moral conviction and a vision of the Indian Society built an institution with indigenous resources, leadership and style of functioning. They wanted to ensure that the college would be integrated with the State and actively engage in its development as a partner.

It has been a long time since I left U C College, but the values and life lessons I learned from there stood me in good stead for life. My two brothers and two sisters also studied there, and even to this day, we often share memories of our beloved college and its campus life with great joy. I hope and wish my six year old grandson will have the same joy and love for his alma mater in the future.

Chacko, it is hoped that the endowment will grow to a meaningful size through the contributions of the alumni and friends. Board Members of UCCAANA has already pledged \$4,000.00 towards this fund.

Alumni Meeting in Chicago

A meeting of the Chicago chapter of Union Christian College Alumni Association (UCCAANA) was held on Sept 26, 2010 in Darien IL. Mr. George Varghese of Chicago made the arrangements for the meeting. In addition to alumni from the Chicago area, Dr. Simon Thomas, Vice President of UCCAANA and Prof. Titus Mathews of Calgary, Advisor to UCCAANA attended the meeting. Prof. Titus Mathews gave an overview of the planned start of a Center for the Study of Religion and Society (CSRS) in UCC, a brochure for which was launched on Sept 6th in Aluva by the Mar Thoma Valia Metropolitan Mar Chrysostom. Dr. Thomas also reviewed the ongoing UCC Navathi Celebrations and associated program initiatives in UCC. The attendees discussed opportunities to increase membership of the association in the Chicago and neighboring areas.

We had notable accomplishments in some areas in 2010. We hope and plan to improve and accomplish more in the areas of our organizational growth and activities which promote our stated goals and objectives as an alumni association in 2011.

We thank all the alumni in North America for their support and request them to get more involved with UCCAANA. We also thank all the staff, faculty members and the members of the Governing Body of UCC for their support and encouragement.
