It should not be used for any purpose other than to quickly establish a highly visible incident response area. NEVER DRIVE WITH THE FLAG BANNER ATTACHED TO THE VEHICLE. The flag banner component in the COMMAND GOBAG is not designed for winds greater than 50 mph or outdoor use for more than 3 days.

LIMITED 1 YEAR WARRANTY
