This is the Client Relationship Summary for Financial Justus LLC an SEC-Registered Investment Adviser. Brokerage and Investment Advisory services and fees differ, and it is important that you understand those differences.

What investment services and advice can you provide me?

The investment advisory service we provide is a comprehensive service that combines financial planning and portfolio management services. Clients may also elect to receive tax preparation services as a part of our service.

Our comprehensive service provides continuous monitoring of your investments.

For clients who choose our comprehensive service, we take discretionary authority in your account, which allows us to buy and sell investments in your account without asking you in advance.

We do not have minimum account sizes or investment amounts.

Ask us: Given my financial situation, should I choose an investment advisor service? Why or why not? How will you choose investments to recommend to me? What is your relevant experience, including your licenses, education and other qualifications? What do these qualifications mean?

What fees will I pay?

For our Wealth Management service, you will pay a fixed annual fee plus a percentage of assets under management. The fee is payable in quarterly installments, in arrears. You should be aware that the more assets there are in your account, the more you will pay in fees. This means we have an incentive to encourage you to increase the assets in your account; however, there is a cap associated with our fees for accounts between \$5,000,000-\$9,999,999, which means that, generally while clients do pay more in fees as their assets with us grow, once a client's assets with us reaches an amount in that range, we will not charge additional fees until the client's assets with us reach \$10,000,000. You will also incur other fees including brokerage fees and commissions, management fees for mutual funds and ETFs, custodian fees, retirement account annual fees, trade ticket charges, or banking fees in connection with an investment account and the securities in the account; we do not receive any of these fees.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying. For more information, please review our disclosure brochure in Items 5 A, B, C, and D of ADV Part 2A.

Ask us: Help me understand how these fees and costs might affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs, and how much will be invested for me?

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You

should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means.

While we work to minimize conflicts with clients, simply setting a fee for our services creates a conflict as it incentivizes us to charge you more rather than less for our services.

Ask us: *How might your conflicts of interest affect me, and how will you address them?*

How do your financial professionals make money?

Our firm's only compensation comes from our advisory fees. Our employees receive salaries for the work they perform on your behalf. Those with ownership interests in the firm receive profit distributions. No one at the firm – other than as described – is compensated based upon the amount of client assets they service; the time and complexity required to meet a client's needs; the product sold (i.e., differential compensation); or product sales commissions.

Do you or your financial professionals have legal or disciplinary history?

Ask us: *As a financial professional, do you have any disciplinary history? For what type of conduct?*
