How do I pay my monthly dues?

AutoPay: 6 month commitment, regardless of attendance, renewable at 6 month mark

All autopay contracts automatically renew after 6 months unless a WRITTEN NOTIFICATION of cancellation is submitted 30 days prior to upcoming payment (text, email or verbal notifications are not allowed). Dues may only be cancelled at 5 month mark unless prior permission given. There is a \$35 fee for all NSF or failed credit card collections. Uncollectable fees will be turned over to Cornerstone Collections after 30 days; student will not attend classes until all payments are received in full unless prior arrangements are made.

Monthly payment plan by cash & permission only, due on 1st class of the month: \$20 extra per month

Are there yearly membership fees?

TKD/Hapkido: Annual membership fee to USA Taekwondo (USAT), a national organization, which needs to be paid directly to USAT. The current yearly fee is \$45 per student (for three or more, family rates are available). More information is available from our Instructors, or online at usa-taekwondo.us. For the first year only, fill out the paperwork provided & turn in to your Instructor. In subsequent years, you may renew the membership online (family memberships are paper only at this time, per USAT).
