MINUTES OF A REGULAR MEETING OF THE BIG SPRING FIREMEN'S RELIEF AND RETIREMENT FUND BOARD OF TRUSTEES SEPTEMBER 12, 2024

The Big Spring Firemen's Relief and Retirement Fund Board of Trustees held a regular meeting on Thursday, September 12, 2024 at 8:30 a.m. in the Big Spring City Council located at 307 East 4th Street, Big Spring, Texas 79720, pursuant to notice.

CALL TO ORDER: Chairman Chanley Delk called the meeting to order at 8:41 a.m.

APPROVAL OF MEETING MINUTES: August 8, 2024 Regular Meeting: The Board reviewed the August 8, 2024 regular meeting minutes. A motion was made by Trustee Darden and seconded by Trustee Pederson to approve the August 8, 2024 regular meeting minutes as written. Motion carried by roll call vote.

REVIEW/APPROVE – LAUTERBACH & AMEN, LLP MONTHLY FINANCIAL REPORTS: The Board reviewed the Monthly Financial Report for the Medical Subsidy Fund for the seven-month period ending July 31, 2024 prepared by L&A. As of July 31, 2024, the net position held in trust for pension benefits of the Medical Subsidy Fund is \$847,845.94 for a change in position of \$63,411.93. The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report and the Monthly Disbursement Report for the period July 1, 2024, through July 31, 2024 for total disbursements of \$3,914.93.

The Board also reviewed the Monthly Financial Report for the Retirement Fund for seven-month period ending July 31, 2024, prepared by L&A. As of July 31, 2024, the net position held in trust for pension benefits of the Retirement Fund is \$16,940,112.58 for a change in position of \$740,700.30. The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report and the Monthly Disbursement Report for the period July 1, 2024 through July 31, 2024 for total disbursements of \$2,610.90.

A motion was made by Pederson and seconded by Trustee Sparks to accept the Monthly Financial Reports as presented and to approve the disbursements shown on the July Monthly Disbursement Reports in the amounts of \$3,914.93 and \$2,610.90. Motion carried by roll call vote.
