**REVIEW/APPROVE – LAUTERBACH & AMEN, LLP MONTHLY FINANCIAL REPORTS:** The Board reviewed the Monthly Financial Report for the Medical Subsidy Fund for the eight-month period ending August 31 prepared by L&A. As of August 31, 2024, the net position held in trust for pension benefits of the Medical Subsidy Fund is \$862,218.37 for a change in position of \$80,784.36. The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report and the Monthly Disbursement Report for the period August 1, 2024, through August 31, 2024 for total disbursements of \$2,670.91.

The Board also reviewed the Monthly Financial Report for the Retirement Fund for eight-month period ending August 31, 2024, prepared by L&A. As of August 31, 2024, the net position held in trust for pension benefits of the Retirement Fund is \$17,208,453.69 for a change in position of \$1,009,041.41. The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report and the Monthly Disbursement Report for the period August 1, 2024 through August 31, 2024 for total disbursements of \$719.24.
