MINUTES OF A REGULAR MEETING OF THE ORANGE FIREMEN'S RELIEF AND RETIREMENT FUND BOARD OF TRUSTEES AUGUST 23, 2023

A regular meeting of the City of Orange Firemen's Relief and Retirement Fund Board of Trustees was held on Wednesday, August 23, 2023 at 1:00 p.m. at 501 N. Central Fire Station Orange, Texas 77630, pursuant to notice.

CALL TO ORDER: Chairman Gravett called the meeting to order at 1:00 p.m.

ACCOUNTANT'S REPORT – LAUTERBACH & AMEN, LLP: Monthly Financial Report and Presentation and Approval of Bills: The Board reviewed the Monthly Financial Report for the six-month period ending June 30, 2023 prepared by L&A. As of June 30, 2023, the net position held in trust for pension benefits is \$9,054,539.04 for a change in position of \$612,549.56. The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report, and the Vendor Check Report for the period March 1, 2023 through May 31, 2023 for total disbursements of \$25,078.95. A motion was made by Trustee Gravett and seconded by Trustee Riedel to accept the Monthly Financial Report as presented and to approve the disbursements shown on the Vendor Check Report in the amount of \$25,078.95.
