REVIEW/APPROVE – LAUTERBACH & AMEN, LLP MONTHLY FINANCIAL REPORTS: The Board reviewed the Monthly Financial Report for the Medical Subsidy Fund for the twelve-month period ending December 31, 2023 prepared by L&A. As of December 31, 2023, the net position held in trust for pension benefits of the retirement fund is \$784,434.01 for a change in position of \$112,552.64. The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report and the Monthly Disbursement Report for the period December 1, 2023, through December 31, 2023 for total disbursements of \$2,669.21.

The Board also reviewed the Monthly Financial Report for the Retirement Fund for the twelve-month period ending December 31, 2023, prepared by L&A. As of December 31, 2023, the net position held in trust for pension benefits of the retirement fund is \$16,179,178.95 for a change in position of \$1,971,111.16. The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report and the Monthly Disbursement Report for the period December 1, 2023 through December 30, 2023 for total disbursements of \$2,730.02.
