The Big Spring Firemen's Relief and Retirement Fund Board of Trustees held a regular meeting on Thursday, January 11, 2024 at 8:30 a.m. at the Big Spring City Council located at 307 East 4<sup>th</sup> Street, Big Spring, Texas 79720, pursuant to notice.

**INVESTMENT REPORT** – **RHI:** *Terra Cap Updates:* There was no investment report or Terra Cap update presented.

REVIEW/APPROVE – LAUTERBACH & AMEN, LLP MONTHLY FINANCIAL REPORTS: The Board reviewed the Monthly Financial Report for the Medical Subsidy Fund for the eleven-month period ending November 30, 2023 prepared by L&A. As of November 30, 2023, the net position held in trust for pension benefits of the retirement fund is \$741,866.98 for a change in position of \$69,985.61. The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report and the Monthly Disbursement Report for the period November 1, 2023, through November 30, 2023 for total disbursements of \$3,199.13.

The Board also reviewed the Monthly Financial Report for the Retirement Fund for the eleven-month period ending November 30, 2023, prepared by L&A. As of November 1, 2023, the net position held in trust for pension benefits of the retirement fund is \$15,357,032.17 for a change in position of \$1,148,964.38. The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report and the Monthly Disbursement Report for the period November 1, 2023 through November 30, 2023 for total disbursements of \$13,094.83.

A motion was made by Trustee Sparks and seconded by Trustee Pederson to accept the Monthly Financial Reports as presented and to approve the disbursements shown on the November Monthly Disbursement Reports in the amounts of \$3,199.13 and \$13,094.83. Motion carried by roll call vote.
