A regular meeting of the City of Orange Firemen's Relief and Retirement Fund Board of Trustees was held on Wednesday, July 26, 2023 at 1:00 p.m. at 501 N. Central Fire Station Orange, Texas 77630, pursuant to notice.

ACCOUNTANT'S REPORT – LAUTERBACH & AMEN, LLP: Monthly Financial Report and Presentation and Approval of Bills: The Board reviewed the Monthly Financial Report for the three-month period ending May 31, 2023 prepared by L&A. As of May 31, 2023, the net position held in trust for pension benefits is \$8,752,439.94 for a change in position of \$310,450.46. The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report, and the Vendor Check Report for the period March 1, 2023 through May 31, 2023 for total disbursements of \$44,500.32. A motion was made by Trustee Gravett and seconded by Trustee Riedel to accept the Monthly Financial Report as presented and to approve the disbursements shown on the Vendor Check Report in the amount of \$44,500.32. Deceased Surviving Spouse – Brenda Nezat: The Board noted that surviving spouse Brenda Nezat passed away on April 8, 2023 and noted that L&A sent correspondence to her Estate requesting a repayment of the overpaid benefit in the amount of \$1,220.13, but no response has been received to date. Updates will be provided as they become available.

**NEW BUSINESS:** Review/Acknowledge Receipt – Foster & Foster Actuarial Valuation as of January 1, 2023: Ms. Redman reviewed the 2023 Actuary Valuation with the Board. Based on data and assumptions, the expected municipal contribution rate is 18.8% which produces a 34.5 year amortization period. To achieve a 30 year amortization period as prescribed under Texas Law, the municipal contribution rate is 19.93%. A motion was made by Trustee Gavette and seconded by Trustee Riedel to accept the Actuarial Valuation as prepared by Foster & Foster. Motion carried by roll call vote.
